Sorority Residency Requirement

Per Alpha Chi Omega bylaws, after the executive officers, priority to live in will then go to those members choosing to live in after completing a housing application. All remaining, unfilled spots will be filled by members of the rising new member class. If you choose to live in the house, rooms and house placement comes on a first come first serve basis. If interest exceeds capacity, housing selection will go based on: GPA, Slated Positions, Positive Points, Seniority, and Campus Policy. If the rising new member class does not fill the facility, chapter members who have not met the live-in requirement (lowest GPA and newest member class) will be asked.

Financial Assistance

Carnation Scholarship: Offered for Fall 2024 and Spring 2025 for \$350 towards your semester dues.

Monthly Payment Installments: Semester payments can be broken down into 2 monthly payments for New Members and 3 payments for Actives to help members who can't pay the full amount at one time. For New Members on the payment plan, ½ of their dues will be due by the 15th of September and the other half by the 15th of October. Actives can have their semesterly dues split into three equal payments, due August 31st, September 31st, and October 31st for the Fall and January 31st, February 28th, and March 31st.

Sorority Residency Requirement

Members are required to live in the Chapter House for two semesters during their membership unless they qualify for exemption under specified conditions. Members living in the Chapter House are determined by application, if residency is not filled members will be chosen based on member status from a waitlist. A member is considered to have met the two-semester live-in requirement if she qualifies under one of the following conditions: 1) has lived in the chapter house for two semesters, 2) has submitted the Gamma Chi housing application, or 3) has moved into the chapter house to fill a vacancy (even if not for a full two semesters). Failure to satisfy this requirement will result in a fine of \$350 per semester, up to \$700 total.

Financial Assistance

Payment Plans: Payment plans are available for members who are unable to meet their dues obligations by the specified due dates. These plans are highly customizable to accommodate the specific financial needs of members. It is important to note that the total amount of dues remains unchanged; only the payment schedule may be modified.

Scholarships: Alpha Delta Pi offers various scholarship opportunities, including the Alice Combest Memorial Scholarship. This scholarship can be awarded once during the duration of a member's affiliation and can cover up to the full amount of one semester's dues (\$636.51).



Member Organization Fees

Each organization has a distinctive badge or pin. This fee is for the organization's pin, which can range from simple to ornate and customizable based on the member's preferences and budget. The cost of purchased pin may vary depending on the style, jewels, and any add-ons the member chooses.
One-time payment prior to initiation to support membership commencement procedures.
One-time fee to establish membership in the organization prior to initiation commencement. New members get to experience special events including a new member sleepover and other bonding activities to celebrate their decision to join our chapter.
Membership fee paid to the national organization to fund operational costs and support sorority activities and initiatives for each member.

Chapter Fees

Chapter Dues:	These monies fund member activities including programming, recruitment, chapter supplies, chapter operations, social events, philanthropy events, sisterhood events, and any other special events including but not limited to renting food trucks, putting on concerts, Spring formal, attending local sports events, chapter dinners, etc.

Financial Assistance

Financial Assistance

There are many scholarships available through the Kappa Alpha Theta national's website, as well as a payment plan that members can apply for which breaks up semester dues into even installments over four months. In the fall, each member on a payment plan would pay \$178.50 in August, September, October, and November. In the spring, each member on a payment plan would pay \$133.75. The installments are usually sent out at the beginning of the month and is due two weeks after they are sent out. There is no penalty or fee to be on a payment plan, but each member has to submit a reason as to why they are applying for one each semester. There is also no set number or maximum amount of girls who can receive a payment plan instead of a single installment, and Kappa Alpha Theta is more than willing to make sure that the financial responsibility of our chapter is not a burden to the women in our sisterhood.



Member Organization Fees

Badge and one-time initiation fee:	This fee is to establish membership in Kappa Alpha Theta. It is paid one time during the semester each member would be initiated. Included in this category is our badge fee. Each member organization has a badge/pin. Our pins are in the shape of a kite, which is our chapter's symbol. We wear these pins whenever we have a ritual event, or special occasion within our chapter.

As a chapter, we typically have two to three events per semester, ranging from many different themes and partnering with many different chapters across our campus. These funds are used for busses to and from events, venues, decorations, etc.
Sisterhood Events:	Kappa Alpha Theta hosts many sisterhood events throughout the year. We have planned activities such as workout classes, coffee tabs, flower bouquet-making events, movie nights, build-a-bear making, and more! Our sisterhood events are one of the best parts of our chapter, because it brings together all of Theta and is a way to spend quality time with our sisters.
Ritual:	Ritual is a very special part of Kappa Alpha Theta and is something all of our members hold close to our hearts. We participate in ritual heavily in the fall semester with the initiation of our new members, as well as at chapter meetings each week. These funds are used to purchase supplies to hold and continue these traditions.

Financial Assistance
