Continuous Open Bidding

Continuous Open Bidding, also known as COB, looks very different from primary recruitment. Continuous Open Bidding (COB) is an informal recruitment process that Panhellenic sororities use to recruit new members outside of the designated primary recruitment period to reach quota and/or Panhellenic Total (i.e. Median Chapter size). For example, if Alpha Alpha Alpha sorority has 250 members for the spring semester and Chapter Total 255, then Alpha Alpha Alpha can offer 5 COBs if they are interested. The specific chapters eligible vary each semester, and although chapters may choose to participate in COB, they are not required to.
