  - a. Discussion of the Financial Transparency Bylaws
    - i. Sigma Kappa opens the floor
    - ii. Kappa Alpha Theta seconds
    - iii. Sigma Kappa: I know that our chapter is against round 2. What is the time frame you guys were hoping for it to last? We are confused on the time.
    - iv. Claire: we pulled up the form on NPC and it really breaks it down to nationals and money towards sisterhood events, philanthropy events, badge, etc. and if the fees are different from members in the house versus out of the house. Devin and I came up with around 4 minutes to go through all of those things. In theory it would be someone giving a presentation and breaking down the sheet and why they put the money towards these categories. The hope would be that the women talking to the PNM could answer questions after this presentation. If it took longer that would be fine.
    - v. Alexis to put 4 minutes into perspective, it takes 6 minutes for you to bring in and take out PNMs so this would take less time than entrance and exits
    - vi. Jayne this would be something to talk about with your VP of finance because they probably know best
    - vii. Kat what a cool way for the PNMs to meet someone on exec who isn't the recruitment chair or president
    - viii. Claire we want to get a general consensus for what round you are leaning toward and timing. Are any of you opposed to it being round 3?
    - ix. Chi o we are concered because it is close to preference round and values and sisterhood are more of our focus and connecting with the PNM and we don't want it to pull away from those focuses.
    - x. Pi Phi we are on a similar page and with pairing round 2 and 3 we feel like it could tie into the money that we are raising for our philanthropy
    - xi. Devin we need to get you on the same page for next week. The downside to round 3 is that it's a little further from the front of recruitment, there might be less PNMs and could they have made a better decision earlier on the week financially. The downside to round 2 is they go to 10 chapters will the PNMs get confused and there is less time in round 2. A lot of chapters do presentations in their philanthropy but in round 3 there is less presentations and therefore more time. There is no perfect spot but there is a benefit to round 3 because you get 10 extra minutes. There is less paperwork and less money coming out the dues if we pick round 3 over round 2 but you have to choose what you are comfortable with.
    - xii. Kara some thought behind it on other campuses is it being later rounds become more intimate conversations and talking more about what membership in your chapter looks like and sometimes members are more comfortable to have that conversation with PNMs who have been there for a couple rounds and you are talking about more serious topics.
    - xiii. Fontana you can still have a values-based conversation and connect it to finances. We are not saying that you should make your whole round about your chapter finances because the PNMs don't want to talk about that either. But working with your headquarters on incorporating when it will happen during that round and anything additional your chapter might offer like a payment plan or scholarships
    - xiv. Claire do we feel ready to vote next week?
    - xv. Fontana this is the first time we mentioned a 4 minute minimum mark

- xvi. Pi Phi as far as the presentations is there going to be a way to monitor and will the powerpoint show what the handout shows?
- xvii. Claire kind of both, I think it should be somewhat of a copy of what the PNMs have but I have seen our chapter doa presentation with a pie chart and show what percentage of your dues go to what and if you have anything about scholarships you can include different slides. As long as it has the information it wont be as structured and we will see them all before when the chapter planning documents are due.
- xviii. DG does every chapter have to use PowerPoint?
- xix. Devin it isn't in the Bylaw proposal so as long as you do a presentation and articulate that in the chapter planning document and if the exec board at the time does not think it is a presentation they may push back and ask you add more substance to a presentation. I would hesitate for us to put PowerPoint because it may change over time and it will put you in a box instead of just asking to make it a presentation
- xx. Claire if you chose for it to just be verbal the script would be the planning document of everything you would say
- xxi. Fontana you would provide a visual or some sort of presentation and say why you justify it as a presentation for the following reasons
- xxii. Alexis its already part of the chapter planning document to submit any of the things that are said to the PNM as a group so any sort of speech so this would be another part of that and it wouldn't be a huge addition to the document
- xxiii. Claire I know some of you expressed how to monitor this across chapters. There will be a financial disclosure evaluation for PNMs, so at the end of the day we will deal with this and this wouldn't involve anything on the chapters end but it would ask something like did you receive a financial summary for each chapter you attened on blank round yes or no, do you feel the financial responsibilities are adequate, do you share this information with your parents or guardians but it's a survey for the PNMs
- xxiv. Devin there was also a survey for active members to be sure that they are being prepared adequately by the chapter to have conversations, so I think NPC is really looking to make sure that our chapters are active in this. Having a presentation will help you all to get adequate feeback from your chapter members and the PNMs about your implementation of this so I think that really does incentivize our chapters and sets them up for success in setting a good minimum so they have enough time and making sure they have a quality presentation so that people leave retaining the information they were supposed to
- xxv. Fontana I also want to highlight that our bylaws are fluid and constantly changing, so we are setting this up it's a policy we worked with NPC, so we didn't have to do it this past fall. But if it doesn't work well or if we decide on a length of time that we don't necessary like this is not set in stone forever so please take that into consideration.
- xxvi. AXO is there a reason why they want the chapter to specifically to give it rather than just getting a booklet
- xxvii. Fontana yes, we had a lot of discussions about this in the spring, it's because you know your chapter best and you know what your dues are and your finance chair knows where that goes and you know the value of your membership. A rho gamma or Panhellenic exec or booklet is not going to be able to articulate how much the sorority experience means to you and how much it could impact this PNMs life and all the opportunities you have within your own chapter. It goes way beyond it and PNMs have been asking for it for years and all of our national chapters voted on this at the NPC level because they thought we needed to be having this conversation.
- xxviii. DG is there a way to put that breakdown in the booklet?
- xxix. Fontana I don't think you want that because when we get to round 2 or 3 not every PNM has access to the same financial information because not everyone is visiting the same chapters. It also becomes a little bit of an overload. It is a different experience than saying here are 13 budgets, good luck. They still have the sheet of paper that they can have past the conversation in the chapter room.
- xxx. Jayne also, we are limited as Panhellenic for what we can see and share
- xxxi. Claire from NPC: recommendation to list only the average cost of sorority membership in college Panhellenic booklet rather than comparative fees because the variance in items included does not provide accurate information and the difference in total fees is almost inconsequential, the college Panhellenic may vote to allow chapters to share detailed financial information during the round of recruitment.
- xxxii. Devin Part of it is us needing to trust that these expert women agreed that this is what was best for our own organizations. There is assurance that we can trust this supreme council.
- xxxiii. ADPi would the survey be the only form of evaluation or would there be an objective person in there to watch and evaluate because PNMs do have favorite house and I would hate to see a PNM be bias and that come back and impact a chapter
- xxxiv. Claire I think the survey would more be about did you receive the information and understand it. With next year's Panhellenic Exec, I would assume they would watch because it is the first year this is happening.

- xxxv. Devin the year they implemented no skits they presented those rounds to exec during work week so that is another thing we could do this semester, so everyone feels confident. Also, mock recruitment would be another strategic time to present this and practice.
- xxxvi. Claire if you know your chapter is leaning toward round 2 or 3 can you share?
- xxxvii. Everyone: round 3 except one chapter
- xxxviii. Claire this is the first one we will vote on
- xxxix. Fontana asked about the 4 minutes. Everyone wanted it to be less than 4 minutes
