 - 1. Article V. The Panhellenic Council Section 10. Vote Requirements
 - a. Proposed motions on issues that impact a chapter as a whole must be announced at least two weeks prior to the scheduled vote to allow opportunity for chapter input before a vote may be taken on the issue.
 - A two-thirds vote of the Panhellenic Council shall be required to approve a re-establishment plan, for all extension-related votes, and to change or establish recruitment rules and bylaws. All other votes, unless specified in these bylaws, shall require a majority vote for adoption. (See the Article XIV on Amendment of Bylaws for specific voting requirements for the amendment of these bylaws.)
 - c. In the event of a tie, chapters shall revote, with a runoff between options, if possible, until the appropriate majority is reached. If the majority cannot be reached, then the motion fails.

 - 1. If a recruitment counselor withdraws from the process at any point, the corresponding chapter will be assessed a penalty. The fine will be \$250 after March April 15th, \$500 after May 1st 15th, or \$750 after August 1st
 - ii. To amend Texas Christian University Panhellenic Bylaws, Article IV. Philanthropic Events, Section 1. Event Parameters, E. as follows:
 - 1. No shoe polish, glitter, confetti, paint, fliers, posters, chalk or anything of the like shall be posted on the hosting chapter's house or anywhere on Texas Christian University property. There may be Yard signs, fliers, and/or posters may be hung at the BLUU, KFCB, and in residence halls in the windows of the competing chapters, pending approval by Texas Christian University and Fraternity and Sorority Life from and according to University Unions, Housing and Residence Life, and Fraternity and Sorority Life policies.

- iii. To suspend Texas Christian University Panhellenic Bylaws, Article III. Recruitment Rules, Section 14. Other. C. as follows:
 - 1. C. All primary recruitment bylaw revisions and additions must be finalized by March 1st. To pass any changes to the recruitment bylaws after this date, the revision must pass unanimously. Suspended until December 31, 2021.
- iv. To propose the addition to Texas Christian University Panhellenic Bylaws, Article III. Recruitment Rules, Section 11. General Conduct. B. as follows:
 - 1. Official hashtags or hashtags commonly used to target the incoming class (#tcu2025, #tcu25, etc.) shall be used exclusively by official chapter and Panhellenic social media accounts and should not be used on personal accounts of individual members.

The TCU Panhellenic Executive Board is currently following the guidance of the National Panhellenic Conference by planning both virtual and in-person options for Recruitment 2021. The format for Round 1 has already been determined after a unanimous vote cast by the Chapter Delegates affirmed the Recruitment Committee's (i.e. Recruitment Chairs and the Vice President of Recruitment Operations) recommendation to utilize chapter videos according to updated guidelines from Recruitment 2020. The exact formats for Rounds 2, 3, and 4 will be determined this summer as we await decisions on several critical variables. These variables include chapter room and other university space capacities, face covering requirements, necessary spacing for social distancing, the length of time/days needed to accommodate the predicted number of PNMs each round, and other TCU, CDC, and NPC guidance to safely conduct an event at the magnitude of Panhellenic Recruitment. There will not be a Panhellenic Council vote to confirm the format for Rounds 2, 3, and 4 because we are already adhering to NPC guidance by planning both virtual and in person options, the Panhellenic Council is not

permitted to conduct business over the summer, and decisions on the aforementioned pending variables must be made by other entities.

The Recruitment Committee will be consulted if there are ever multiple university and FSL approved options to choose from. The Recruitment Committee has been instructed to formulate both in person and virtual options for Rounds 2, 3, and 4 and they are strongly encouraged to be thorough in preparing for either outcome. Pending decisions from TCU, the CDC, and NPC, we hope to have more information about recruitment formats for each round by July 1st. In the meantime, we strongly encourage chapters to be attentive to detail with any orders they are placing or contracts they are signing to leave room for cancellations or changes.

We will do our best to provide updates as soon as possible and are here if you have any questions. Most importantly, please know how proud we are of our chapters and the commitment and resilience you have shown to make the best of any situation. We are fully confident that, regardless of format, each of you will be tremendous hosts for the PNMs in Recruitment 2021.

 - iii. Bylaw of the Week Article V. The Panhellenic Council. Attendance

- 1. The Panhellenic Delegate and Associate Delegate from each chapter must attend each Panhellenic Council meeting. Chapters may have a substitute if either regular representative is unable to attend.
 - a. Consistent failure is three non-University excused absences.
 - b. Mediation will occur after the second non-University excused absence.
 - c. The fine will be \$50 per non-University excused absence after three absences. Failure to have a substitute present will result in an automatic \$50 fine.
 - d. Consistent University excused absences should have a consistent substitute for the duration of the absence.
- iv. Let's refresh about the Parliamentary Procedure in regard to the three weeks of voting!
 - 1. Week 1: Presentation
 - a. Bring to chapter. Gather questions, concerns, comments to bring to discussion.
 - 2. Week 2: Discussion
 - a. Inform chapter and chapter resources of matters discussed and decide how to vote. Make sure that your vote reflects your entire chapters opinion as well as our headquarters opinion.
 - b. President will begin the bylaw change discussion by asking if there is a motion from the floor.
 - c. A Delegate will then need to:
 - i. Make a motion to open the floor
 - ii. Second the motion
 - d. From there ask questions! State your chapter's name before asking a question. Within the discussion, delegates can:
 - i. Move to extend discussion if your chapter needs more time to discuss
 - ii. Move to make an amendment to the proposed bylaw change
 - Once the discussion has ended, a delegate will need to:
 - i. Move to close the floor
 - ii. Second the motion
 - 3. Week 3: Voting
