#### **OLD BUSINESS:**

<u>Lighting:</u> 60-watt daylight bulbs are the approved bulbs throughout the complex. (Garages, Detached Garages, Stairwells, All Buildings etc.) This adds better lighting for safety and security plus standardizes the look of the community. **Phase 1, 2 and 3 have been completed with one exception:** Mushroom lights will be added from the mailbox along the rental parking area.

<u>Fencing Project Walk Thru:</u> Final walkthrough: A Friday (rather than Saturday) date will be scheduled where the Board, Tom and the Fence Company can all be present for the walkthrough.

<u>Kiley Court Shared Fence Replacement:</u> (V and W Buildings) Fencing is completed. Painting will come later.

# Tandem Parking Spots (Fits 2 cars in one spot) – South end of Complex:

1 spot is available for rent. Cost has been reduced to \$65.00 a month.

# **Mailbox Parking Spots:**

M2, M3, M4. Cost is \$50.00 a month. Only those renting these spots can park in them.
