- 1. Building Code:** **Unknown or does not meet the requirements of Answer A or B**
Comments: The year of construction was verified as 1990 per Pinellas County Property Appraiser.
- 2. Roof Covering:** **No roof coverings meet the minimum requirements**
Comments: This building utilizes multiple roof sections and coverings of all different ages. Based on our research with the local building department we were unable to locate all the roof replacement permits for each section. If additional information becomes available, this report will be revised.

Comments: At time of inspection there was no attic access.
