Purchase price: \$2,200 owed at pickup or 72 hours prior online. \$500 deposit is required. Putting a deposit down on a puppy ensures it will not be sold to anyone else. If the puppy is flying or if requested to meet away from breeder/seller's house, the flight nanny or driver will be an additional cost. Puppy will need to be paid in full a week prior to travel.

PLEASE INITIAL _____ (buyers initial) _____ (breeder/seller initial)

The buyer must provide a veterinarian examination within 72 hours of acquiring possession of said puppy from the seller/breeder. This will be at buyer's expense and is for the buyer's protection and to ensure the buyer is purchasing a healthy puppy. _____ (buyer initials) (breeder/seller initials) _____. A copy of this exam needs to be forwarded to breeder and on file to have any warranty needs addressed. If this is not on file with our kennel, your warranty of your puppy will be invalid. _____ (buyer initials) _____ (breeder initials).

The breeder/seller will provide a 72-hour limited health warranty. The buyer is required to take the puppy for a veterinary examination within 72 hours of purchase/possession to verify health of dog. Puppy should not be exposed to other animals or public places until after receiving the final round of puppy vaccination from your veterinarian. If the buyer fails to take the dog to the veterinarian within 72 hours, all health guarantees are void. If upon examination the veterinarian finds the dog is not in good health, the buyer must notify the seller within 24 hours. At the buyer's expense, the puppy shall be returned to the seller along with the veterinary documentation. The seller, Raccoon Creek Corgis, agrees to replace the puppy when one is available or refund the purchase the price.

The buyer realizes that the purchase of above puppy carries with it risk of contracting bacteria or viruses that are not in control of either buyer or seller. Seller offers no guarantee against contracting an infectious disease beyond the seventy-two (72) health warranty. No guarantees are given against Coccidia, Giardia, Kennel Cough, parasites, demodex, hernias during the seventy-two (72) hour limited health warranty.

The breeder/seller also provides a 1-year guarantee against genetic defects that have been proven to have caused the puppy/dog's death. Should this ever occur, the genetic defect must be certified by a licensed veterinarian's autopsy to confirm the cause of death. Buyer understands that the following genetic defects are not considered serious, nor life threatening and are therefore not covered: *low-grade heart murmur, under-bite, overbite, umbilical hernia, undescended testicle, and etc...* In the case of such an event, the breeder will replace the puppy/dog with a puppy of equal quality as available from future unreserved litters.

Travel for puppies under the warranty is buyer's responsibility. Whether you choose to travel to pick up the puppy or to have the new puppy shipped, it is buyers responsibility.

Between the ages of 12-24 months-old, your puppy must be spayed/neutered. No earlier or later than 12-24 months should your dog/puppy be spayed or neutered.

Before purchasing, the buyer has the responsibility to ascertain that there are no known conditions that would require re-homing the puppy/dog. The BUYER hereby agrees that if at ANY TIME the BUYER cannot continue to take proper care of the puppy/dog, the BUYER must contact the SELLER/BREEDER and the SELLER/BREEDER will have the first choice to either: (a) take the puppy/dog back or (b) assist the BUYER in finding a suitable home for the puppy/dog. If at any time the BUYER needs to return the puppy/dog to the SELLER/BREEDER, it must be with the SELLER/BREEDER's permission and there will be a strict NO REFUND POLICY. _____ (buyer Initials) _____ (breeder/seller Initials)

The BUYER will provide the dog with proper nutrition with Science Diet, Nutro, Open Farm, Lifetime, Life's Abundance, Farmina N&D, Sunday's, Spot and Tango, Farmer's Dog, Wellness core, Firstmate, We Feed Raw, FRESH FOOD (not table scraps), or Nulo ONLY.
*****ONE OF THESE FOODS MUST BE FED DURING THE TWO-YEAR WARRANTY PERIOD OR THE WARRANTY WILL BE VOIDED. THIS IS TO ENSURE THAT HEALTHY NUTRITION IS BEING GIVEN TO YOUR PUPPY

In the event of any dispute the venue for such dispute litigation is to be filed and heard in the county of the SELLER/BREEDER's residence, named here as Vinton County, Ohio.
