The buyer must provide a veterinarian examination within 72 hours of acquiring possession of said puppy from the seller/breeder. This will be at buyers's expense and is for the buyer's protection, ensuring the buyer is purchasing a healthy puppy. A copy of this exam needs to be forwarded to the breeder and on file to have any warranty needs addressed. If this is not on file with our kennel, your warranty of your puppy will be invalid.

The seller/breeder will provide a 72-hour <u>limited health warranty</u> . The buyer is required to take the puppy for a veterinary examination within 72 hours of purchase/possession to verify health of dog. Puppy should not be exposed to other animals or public places until after receiving its health check by licensed veterinarian. If the buyer fails to take the puppy to the veterinarian within 72 hours, all health guarantees are void. If upon examination the veterinarian finds the dog is not in good health, the buyer must notify the seller within 24 hours. At the buyer's expense, the puppy shall be returned to the seller along with the veterinary documentation. The seller, Parish Fox, agrees to replace the puppy when one is available or refund the purchase the price (Buyer Initials), (Seller/Breeder Initials)
BUYER REALIZES THAT THE PURCHASE OF ABOVE PUPPY carries with it risk of contracting bacteria or viruses that are not in control of either buyer or seller. Beyond the seventy-two (72) hour health guarantee, seller offers no guarantee against contracting an infectious disease. No guarantees are given against Coccidiosis, Giardia, Kennel Cough, parasites, demodex, hernias during the seventy-two (72) hour limited health warranty. (Buyer Initials)(Seller/Breeder Initials)
The seller/breeder also provides a one-year guarantee against genetic defects that have been proven to have caused the puppy/dog's death. Should this ever occur, the genetic defect must be certified by a licensed veterinarian's autopsy to confirm the cause of death. Buyer understands that the following genetic defects are not considered serious, nor life threatening and are therefore not covered: low-grade heart murmur, under-bite, overbite, umbilical hernia, undescended testicle, hip dysplasia and etc In the case of such an event, the BREEDER will replace the puppy/dog with a puppy of equal quality as available from future unreserved litters. Travel for puppies under the warranty is buyer's responsibility. Whether you choose to travel to pick up the puppy or to have the new puppy shipped, it is buyer's responsibility
