The LME-MCO initially screens individuals seeking or needing mental health developmental disabilities and/or substance abuse services and refers individuals to Provider participants. Individuals who are in need of mental health, developmental disability and/or substance abuse services choose providers for their services from a list of provider participants approved by the LME-MCO. Provider represents that it is a qualified provider of one or more mental health, developmental disabilities and/or substance abuse services. This Contract sets forth provisions pursuant to which Provider will provide mental health, developmental disabilities and/or substance abuse services to individuals who have chosen a Provider for such services.

Community service is work performed by an offender for the benefit of the community. It offers a way for the offender to be held accountable and to repair some of the harm caused by their actions.
