RULES AND REGULATIONS

- No applications will be accepted after the deadline of 3 pm, Friday, July 16, 2021. All acts must be appropriate for fair audiences and not exceed 4 minutes, 2 minutes will be allowed for setup and tear down. A completed application must include:
 - Application Form
 - Description of Act to be Performed
 - Audition Recording
- 2. Curry County Fair Talent Show Coordinator(s) shall have sole authority in selecting acts in the contest, scheduling of those selected, and controlling stage sets, sound, lights, power and overall (master) volume.
- 3. A contestant may submit a maximum of 2 applications and may perform in a maximum of 2 acts. If performing in more than one act they may not be in the same talent category, i.e., 2 solo dances, 2 group performances. Acceptable examples include, but are not limited to, one group dance and one solo dance, one magic performance and a group/ band performance, etc.
- 4. Once a contestant has won the annual Curry County Fair Talent Show, he/she/they will not be eligible to will not be eligible to compete in the same age division for the following two years at the Curry County Fair.
- 5. If a contestant has qualified for the talent contest and is unable to appear, then the act forfeits its opportunity to compete. Replacements may be selected by the Talent Show Coordinator(s).
- 6. All instruments are the sole responsibility of the act.
- 7. Accompaniment: Vocal contestants may use a recorded accompaniment CD with vocal background, but there can be no lead vocals on the trackFor recorded accompaniment, a CD with only one track is recommended. No Cassette tapes will be accepted per State Competition requirements.
- 8. All contestants will perform under the same lighting and sound system provided by the Curry County Fairgrounds and/or stage sponsor. The stage manager will have absolute control over the system. No modification to instruments, sound or lights are to be made by any attraction without prior approval of the stage manager and Talent Show Coordinator(s). Unauthorized modification will result in a forfeiture of contestants' opportunity.
- 9. Each contestant participating on stage will receive free admission into the fair for the day they will be competing.
- 10. The Curry County Fair Talent Competition may be taped. All acts give the Curry County Fair and its sponsors the right to use the taped performances in any way necessary to promote the contest in future years with no additional residuals or payment.
- 11. Immediate family members of Fairgrounds Employees are ineligible to compete in the contest.
- 12. All judges' decisions are final.
- 13. First place winners in the Children's, Youth, and Adult divisions may qualify to participate in the Oregon State Fair Talent Competition. The act performed at the Curry County Fair Competition must be the act performed at the State Competition.
- 14. A cash prize will be awarded to each 1st Place act, in each age division.

Acknowledgement of Rules and Release of Liability

Each contestant participating in the Douglas County Fair's Got Talent Competition must acknowledge that they have read and agree to the rules listed above by signing below.

In consideration of the acceptance of the application, the entrant agrees to indemnify, hold harmless and defend any actions against the Curry County Fair, Fair Sponsors, and their officers and their employees from and against all liabilities whatsoever arising out of their participation in the Curry County Fair and/or Talent Competition. Submission of entry form does not ensure acceptance to participate in the Talent Competition. Curry County Fair's Talent Competition Committee approval required.
