Rules and Information:

1. Fire lanes must be kept open at all times.
2. All campers are required to have a valid permit. Compliance is mandatory, and failure to obtain a permit will result in removal from the Fairgrounds.
3. Campsites are numbered, and campers must occupy only the designated space assigned to them.
4. All campers must be registered with the appropriate group leader (4-H, FFA, etc.).
5. Dumping of grey water is strictly prohibited.
6. Dogs must be kept under control and remain quiet at all times. Dogs deemed a nuisance or danger, or owners who fail to comply with these rules, may result in removal from the Fairgrounds. All County and City leash laws must be followed.
7. Reservations are considered complete only upon receipt of full payment.
8. Permits are valid only for the duration of Fair week.

I, the undersigned, acknowledge and agree that the assigned space at the Curry County Fairgrounds shall be used in accordance with the terms and conditions of this permit.

Any vehicle parked outside the assigned space may be towed at the owner's expense. If the vehicle owner cannot be contacted, the Fairgrounds may authorize towing without further notice. The vehicle owner shall be responsible for all towing and storage costs. The Curry County Fairgrounds will make reasonable efforts to contact the owner and will document all contact attempts prior to authorizing a tow, consistent with Oregon law.

The Permittee agrees to indemnify, defend, and hold harmless Curry County, the Curry County Fairgrounds, the Curry County Fair Board, and their officers, employees, and agents from and against any and all claims, demands, damages, losses, liabilities, costs, or expenses, including attorney fees, arising out of or related to the Permittee's use or occupancy of the premises, except to the extent caused by the sole negligence of Curry County.

The Curry County Fairgrounds and Fair Board shall not be responsible for loss or damage to personal property due to fire, theft, or other causes, except as required by Oregon law.

The Fairgrounds reserves the right to immediately terminate this Agreement and require Licensee to vacate the premises for failure to comply with this Agreement, applicable laws, or Fairgrounds rules. No refund shall be due upon termination for cause.
