### **Acceptable Use**

- **USPS Ground Advantage**

Delivery (tracking service is included) within the US in 2-5 business days for large envelopes and packages up to 70 lbs.

- **UPS Ground**

Delivery in 1-5 business days (based on distance to destination)

Delivery will take place as soon as reasonably possible, depending on the delivery method selected. Delivery times may vary due to unforeseen circumstances. Please note that delivery times do not include weekends and statutory holidays.

You will be required to pay delivery charges in addition to the price for the goods you purchase.

If you purchase goods from us for delivery to a destination outside the United States your purchase may be subject to import duties and taxes applied by the destination country. You are responsible for paying any such duties or taxes. Please contact your local customs office for more information before making a purchase. We are not responsible for the payment of any such duties or taxes and are not liable for any failure by you to pay them.

You are required to provide us with a complete and accurate delivery address, including the name of the recipient. We are not liable for the delivery of your goods to the wrong address or wrong person as a result of you providing us with inaccurate or incomplete information.

**Consumer Protection Law**

Where any consumer protection legislation in your jurisdiction applies and cannot be excluded, these Terms and Conditions will not limit your legal rights and remedies under that legislation. **Additional Terms**

- Bulk orders (five or more of a single item) and customized orders may take up to 14 business days to make before being shipped; and
- Customers ordering 10 or more of a single item are encouraged to contact the company via email before placing the order. Once the owner and the customer agree on the manufacturing and shipping timeline, that customer will become the priority for goods made and shipped..

**Severability**
