Here are some friendly reminders from our HOA CC&Rs:

# On-Street Parking Section 5.19

"On-street parking is limited to guests, whether extended stay or frequent, and shall not be used as regular parking of home-owner vehicles, trailers, RVs, etc."

For safety and courtesy, the sidewalk in front of your home should never be blocked by vehicles, RVs, etc.

# Garage Doors Section 5.21

"Garage doors shall be closed except when opened for temporary purpose."

# Parking Strip Landscaping Section 5.27 (d)

Homeowners are responsible for planting and maintaining one tree in the parking strip area.

# Barking Dogs Section 5.10

"Barking dogs will be considered a nuisance and dealt with according to city regulations."
