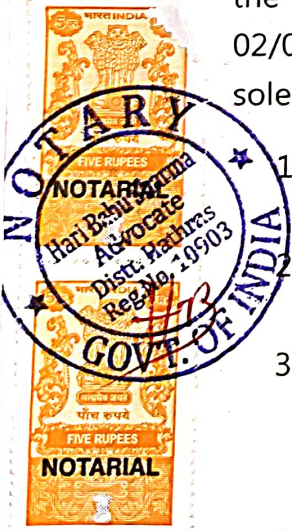

3. That the school is being run as a community service and not as a business and that commercialization does not take place in the school in any manner what's do ever.

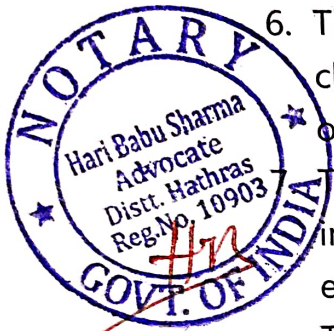




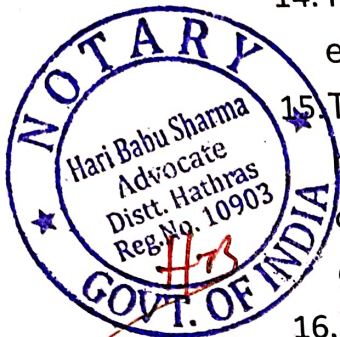
students/parents every year before start of session without resorting to any hidden charge in the heads of the fee.
