- **Included:** 6 days of fishing, 7 nights of boutique hotel accommodation, Airport transportation, Fishing license, all meals, non-alcoholic beverages, and local beer.
- **Not Included:** Airfare, other meals or alcohol out of the package, live bait, and gratuities.
- **Gratuities (Cash in USD preferred):**
 - **Captains:** \$70/day (minimum) per person + \$30/day for bait.
 - **Hotel Staff & Kitchen:** \$150 (minimum) per guest for the week.
 - **Maid Service:** \$70 / \$100 respectively for the week.
- **The Experience:** Breakfast is served one hour before launch. We depart from the Hotel beach or Ensenada de los Muertos. We are typically back by 2:00 PM for siesta, snacks, and gear maintenance at the hotel's rinse stations.
