Do you know that ALS is a significant threat to the veterans' community?

Since 1910, multiple studies have shown that the rate at which U.S. veterans develop amyotrophic lateral sclerosis — also known as Lou Gehrig's disease — is twice as high as the American general population. Despite this, there's a shockingly low amount of awareness of the disease among the veteran community.

I should know. I was diagnosed with ALS in November 2020. Before then, my only acquaintance with ALS was the "ice bucket challenge". After my diagnosis, I have made a point to ask every veteran I meet if they're aware of the link between military service and the likelihood of being stricken with ALS. I have yet to meet someone who says they do. That needs to change.

COMMANDER'S CORNER

On behalf of VFW Post 2894 I would like to wish everyone a "Merry Christmas" and a "Happy New Year"! God bless us all!

It's hard to believe that in a few days it will be 80 years since what President Roosevelt called "a date that will live in infamy" occurred, December 7th, 1941! What followed was a declaration of war by the United States of America against Japan. Within days, Japan's allies, Germany, and Italy, declared war on the United States, and the country began a rapid transition to a wartime economy by building up armaments in support of military campaigns in the Pacific, North Africa, and Europe.

Immediately Americans from all walks of live rushed to join the military in defend our freedoms, liberties, and the American way of life. This generation of Americans had lived through the "Great Depression" and now were called on to give their lives to keep our country free! This generation became known as the "Greatest Generation"!

One of our Post Comrades is a living member of that generation. His name is Edward L. Vincek Cpl United States Marines Corps. Cpl Vincek survived the invasion of Iwo Jima. Cpl Vincek is 97 years young. Here is part of his story.

"EDDIE VINCEK was born in 1925 and grew up on a dairy farm in upstate New York. In May of 1943 he joined the US Marine Corps; "I was going to be drafted into the war. I didn't want to join the Navy, so, I joined the Marine Corps."

He first was stationed at Norfolk Naval Air Station where he met his future wife, Mary. He was then transferred to the Pacific after infantry training at Camp Lejeune and boarded LST 634 (Landing Ship Tank) bound for Japan. For 42 days he and his brother Marines voyaged across the ocean unsure of whether they would survive. Every day Japanese submarines circled the convoy harassing and threatening them. While the Japanese never fired on the ships, the constant threat of attack kept them on edge.

On February 19, 1945, Eddie landed on the island of Iwo Jima – one hour after the initial landing. "Working on a dairy farm," he explained, "I was used to seeing animal blood, but not human blood spilt over the ground." More than 6,000 Marines died during that invasion.

"I was one of the few that walked off carrying my own gear. So many others had been killed or wounded and weren't able to carry their own gear off the island."

After his honorable discharge as a Corporal in 1946, he returned to Virginia and wed Mary.

Another member of the Greatest Generations is Crowley Daniel W Sgt United States Army

(May 22, 1922-September 16, 2021)

Dan and his wife, Kelley, drove in their Mustang, from Connecticut to Chesapeake, to be our guest of honor for the last three Bataan Death March Memorial Walk events. One thing Dan told us was that they were "Surrendered". They never would have surrendered on their own accord.

"After 76 years, on January 4, 2021, Pvt. Daniel Crowley, a son of Connecticut and a WWII veteran, received his promotion to Sergeant, his Combat Infantryman Badge (CIB), and POW Medal. Dan served in the Philippines with several units: the U.S. Army Air Corps at Nichols Field near Manila, the U.S. Army Air Corps Provisional Infantry Regiment (PARC) that fought the invading Japanese forces on the Bataan Peninsula, and the 4th Marines on Corregidor. He became a prisoner of the Japanese in May 1942. He was liberated from a POW slave labor copper mining camp in Japan in September 1945." Read more about Sgt Crowley's further on in this newsletter.

Daniel W. Crowley, SGT, US Army Air Corps (USAAC) was a bona fide hero and an American icon. He participated in each of our annual Bataan Death March Memorial Walks since 2016. We considered him an honorary member of our Post. He recently passed away at the age of 99. We will miss him terribly. Here is his obituary:

Daniel W. Crowley, former prominent salesman for Northwestern Mutual Insurance, survivor of the Battles of

Bataan and Corregidor and POW of Imperial Japan, passed away peacefully from natural causes on Thursday, September 16, 2021, at his home in Simsbury, Connecticut. He was 99 years old.

He was born May 29, 1922 and raised in Greenwich,

Connecticut. Son of famous women's fashion icon, textile

designer Timothy F. Crowley and Janet (Cook) Crowley, Dan experienced the depths of the Depression when his father's business went bankrupt.

He enlisted in the US Army Air Corps in October 1940 and was sent to the Philippines in March 1941. Mr. Crowley was posted to Nichols Field, which was destroyed when the Japanese attacked on December 8, 1941 and that the United States entered World War II. He fought in the Bataan Peninsula with the US Army's Provisional Infantry Regiment, repelling three Japanese amphibious landings.

After the surrender of the Bataan Peninsula on April 9, 1942 – the largest military surrender in American history – he swam the three miles of shark infested mine water to Corregidor Island in Manila Bay. On Corregidor, Mr. Crowley became a member of the 4th Marines fighting a dangerous and desperate coastal defense until the fall of the island fortress on May 6, 1942.

After surviving a series of brutal working details over the Philippines, in 1944 he was sent aboard a hell ship to Japan. There he was a slave in copper mining, first for the Hitachi company, then for the Furukawa company in their Ashio mine.

Mr. Crowley was released on September 4, 1945 and was at home in Connecticut for Christmas. He first became a traveling salesman dependent on commissions and his intelligence. In 1958 he started working for Northwestern Mutual Insurance, where he quickly became one of their top producers and a member of their Million Dollar club.

Crowley believed he had a good life in Simsbury, but he never forgot the years that were stolen from him by the Japanese. In 2013, he helped have the Route 185 bridge in Simsbury named the "Bataan Corregidor Memorial Bridge" in memory of the soldiers who fought alongside him and lost their lives fighting the Japanese on Bataan and Corregidor.

In October 2014, Mr. Crowley returned to Japan as part of the 5th US-Japanese POW Friendship Program. Unfortunately, the leaders of Furukawa refused to meet with him. However, he revisited one of the mines where he worked.



In 2016, he attended President Barack Obama's Veterans Day breakfast at the White House. And on January 4, 2021, at a ceremony at Bradley Air National Guard Base in Connecticut, U.S. Senator Richard Blumenthal presented Mr. Crowley with his long-delayed promotion to Sergeant, an honorary badge of infantryman. de combat (CIB) and a prisoner of war medal.

He was married for 65 years to Marie Boles who predeceased him in 2012. They had two children, son Daniel W. Crowley, Jr. (deceased) and daughter Janet Sackbauer of Vail, Colorado.

On April 24, 2014, he married Kelley Thomen who accompanied him in 2016 to Washington for the White

House breakfast on President Obama's Veterans Day. Kelley and Janet were by his side when he died.

Besides his wife and daughter, he is survived by his son-



in-law Frederick Sackbauer and his grandchildren Lucy, Mary and Timothy Sackbauer, Daniel William Crowley III and his great-grandson Peyton Crowley.

A public celebration of life will take place at a later date.

Mr. Crowley was a life member of VFW, American Legion, and DAV, as well as the American Defenders of Bataan and the Corregidor Memorial Society.

Eddie Vincek and Mary Roth met during World War II in the summer of 1943. The 19-year-old Marine was in boot camp at Naval Station Norfolk. He and his comrades heard about a dance in Bowers Hill. "My buddies said, let's go," Eddie recalled. "And that's where I met my wife, on the dance floor."

The couple recently celebrated their 75th wedding anniversary Oct. 6.

Eddie Vincek, 97, said they were meant to be together. "She was a country girl and I was a country boy," he said. "We just hit it off."

The pair have a lot in common. Mary was born on a Chesapeake farm and was valedictorian of the Deep Creek High School class of 1942. Eddie grew up on a family dairy farm established in 1920 in upstate New York.

Both of their grandparents came to the U.S. from Czechoslovakia, which meant they were very familiar with the polka the night they met in the social hall of St. Mary's Catholic Church — the same place they were married three years later.

Soon after that dance, Eddie was transferred to Camp Lejeune in North Carolina, then California and Hawaii. In early 1945, Eddie was part of the 5th Marine Division, which fought in the weekslong Battle of Iwo Jima.

American forces overtook the Japanese Island, and the war ended later that year. Eddie was in Japan for another six months.

He came back to the states in April 1946, and was engaged to Mary the following month. The wedding was small, and followed by a trip to New York to visit Eddie's side of the family, members of which couldn't leave their farming livelihood to attend the ceremony.

"That was more or less a honeymoon," he said.

Eddie didn't re-enlist, but went to work for Globe Iron Construction Company in Norfolk. "I got paid 50 cents an hour and had a paycheck of \$21 for five and a half days," he said.

The couple lived with Mary's family in Chesapeake after they were married. "No mail, no lights, no phone," Eddie Vincek said. They still live in the house they built on Shillelagh Road in Grassfield in 1953. The Vinceks raised three children, and have four grandchildren and four great-grandchildren. Their daughter Anne Gwynn lives in Great Bridge.

"We had a great childhood," she said.

Mary Vincek was an avid gardener and spent many years in the "Home Demonstration Club," later named the "Homemaker's Club," a Norfolk County Extension Service organization. She enjoyed canning vegetables, quilting, making ceramics and other crafts. She assisted their church with bazaars, and volunteered at the voting polls.

Eddie's hobbies were woodworking, gardening and fixing lawnmowers and bicycles. Both delivered Meals on Wheels, and for years cooked meals monthly for a Portsmouth soup kitchen.

Vincek said he and his wife are in good health, and don't have a secret to a long, happy marriage.

"We get along and love each other," he said.

They enjoy sitting on their front porch, within view of the flagpole that displays an American flag. Just down the road is Vincek Way, named in Eddie's honor for service to the community.

"We just enjoy life," he said.

Captain Don Sharer, USN (Ret.) was a Chesapeake native who died in Mansfield, TX on September 13th. He was buried in Texas but his daughter, Jennifer Sharer Knight, the Chair of Chesapeake's Historic Preservation Commission, desired to honor his life in his hometown of Chesapeake. She reached out to Past Post Commander Carl Dozier for assistance and he

gladly took on the task of organizing and conducting a memorial service for Capt. Sharer. So on the morning of October 16th a large group of family, friends, dignitaries and admirers gathered at the Veterans Memorial in front of City Hall. A Navy flier with 238 missions over Vietnam, Donald was living in Chesapeake in the late 70's but working in Iran where he was

teaching their naval pilots to fly F-14 Tomcats. On November 4th of 1979 he had the misfortune to be visiting the US Embassy when it was attacked by militarized Iranian college students. For the next 444 days he was a prisoner of the Iranian Revolution. But he was made famous when in February 1980 a group of masked Iranians armed with automatic rifles shoved some Americans into a basement room and ordered them to lie down. Donald refused, telling them, "You're going to have to shoot me standing up -- not lying down." When he returned to Chesapeake he was given a hero's welcome. Don was a Life Member of VFW Post 1686 in Bedford, Indiana and VFW Post 2894 was humbled to be asked to honor his service to country.

"ALS is Killing Veterans" (Continued from page 1)

Every day in America, three veterans are diagnosed with ALS while another three die from it.

The prognosis for a person diagnosed with ALS today is largely the same as it was 150 years ago - death in two to five years.

Towards the end, you are left almost incapable of communicating with the outside world except through your eyes.

I am a retired Marine and have been athletic all my life. I played soccer, rugby, and ice hockey. I refereed professional soccer and officiated all over the globe. I ran marathons and at the age of 60 was still bench pressing 300 pounds. Now I live in a wheelchair, barely able to lift a spoon to my mouth.

In 2007, Brig. Gen. Thomas "Mik" Mikolajcik, USAF (Ret.), testified before Congress about ALS: "If these soldiers were dying in the field — rather than quietly at home — we would leave no stone unturned. We would use the best existing resources to make sure they had whatever they needed to survive." General "Mik" died from ALS on April 17, 2010.

In 2008, the Veterans Administration determined that military service is a presumptive causation of ALS for veterans. As veterans continue to reach the ages commonly associated with ALS, the rate of the disease will continue to increase in this population. I am evidence of that.

According to a VA report, 1,055 veterans die from ALS each year. That means that since 9/11, three times more veterans have been lost to ALS than troops killed in combat in Iraq and Afghanistan combined (20,895 vs 6,896). Interestingly, the Hampton Roads area of southeastern Virginia — where I and 234,476 of my fellow veterans live — is a "hotspot" for ALS cases.

More ominously, a recent 2019 study revealed that the prevalence of ALS among the Post-9/11 deployed veterans is 19.7 per 100,000 over 14 years compared to the US national average of 5.2 per 100,000. Even worse, for some Air Force personnel (pilots, aircraft crew, missile, and combat operation staff) the prevalence is substantially higher -35.1 per 100,000!

And we still don't know why those in uniform bear an outsized burden from this disease.

The good news is that ALS gives veterans an automatic 100 percent disability rating from the VA. I have nothing but the highest of praise for the support I have received from the VA. From home modifications, to an accessible van, powered wheelchair, medical equipment and more, they have taken care of my every need. If you are diagnosed with ALS, do what I did and immediately contact your nearest VFW Service Officer. You — and your family — don't have any time to waste.

The bad news is that our regulatory process does not keep pace with the urgency of ALS. Drug trials drag on a decade or more when most ALS sufferers do not live nearly that long. A diagnosis of ALS is a virtual death sentence and comes with advice to patients to get their affairs in order and to tick off their bucket list while they still can.

ALS is designated as a rare disease not because so few people get it, but because ALS kills so quickly. As many as 30,000 Americans — approximately 5,000 of them veterans — have ALS, with 5,000 new cases diagnosed each year. However, if ALS patients lived for 10 years after diagnosis there would be 275,000 nationwide, a much more noticeable population.

60 percent of Americans don't know that ALS is always fatal. If you know of a veteran who has or had ALS, we need you in this fight. Too often ALS exists in the shadows, and those afflicted pass so quickly they can't speak for themselves. Be their voice.

The veterans' community urgently needs answers and solutions for people with ALS.

I ask the VFW to use their influence and call upon Congress to fund early access to ALS investigational therapies, accelerate therapy development, and increase research on and development of interventions.

We can solve urgent health needs when we put our minds to it. The quick vaccine development during the pandemic proves that. I have already called both Senators Tim Kaine and Mark Warner. Please do the same.

Our nation must take all measures to ensure that our military men and women are at no greater risk of ALS than any other Americans.

Before I was diagnosed, I had no idea that ALS so disproportionately affects veterans. I have made it my personal mission to raise the awareness in the veteran community of the severity of ALS amongst us. Please help by telling other vets, friends, family — everyone — about the outsized threat of ALS to those who are or have served in uniform.

I will fight this battle to my dying breath.

POST RESOLUTION FOR 2022 NATIONAL CONVENTION

At the 10 November Post meeting, the members unanimously approved the following resolution for the next National Convention. The resolution must first be approved at the Department Convention in June:

COMBATING ALS IN THE VETERAN COMMUNITY

WHEREAS, Amyotrophic Lateral Sclerosis (ALS), also known as Lou Gehrig's Disease, is a fatal neurodegenerative disease that destroys the nerve cells that control voluntary muscle function, eventually impacting the ability to move, speak and breathe; and

WHEREAS, from World War II through Operations Enduring Freedom and Iraqi Freedom, and even in peacetime, multiple studies have consistently shown that the rate at which veterans develop ALS is twice that of non-veterans; and

WHEREAS, the Veterans Administration has determined that 90 days or more of military service is a presumptive causation of ALS for veterans; and

WHEREAS, the prognosis for a veteran diagnosed with ALS today has largely remained the same as 150 years ago – death in an average of two to five years with no known cause or cure; every day three more veterans are diagnosed with ALS while another three die from it; and

WHEREAS, those who wore a uniform bear an outsized burden from this disease with three times as many veterans lost to ALS since 9-11 than troops killed in Iraq and Afghanistan combined (20,895 vs 6,896); and

WHEREAS, our Nation must take all measures to ensure that our military men and women are at no greater risk for ALS than other Americans and that their medical and caregiving needs are met; now, therefore

BE IT RESOLVED, by the Veterans of Foreign Wars of the United States, that we call upon Congress to dedicate more resources towards research on causes, development of therapies, and access to treatments for veterans stricken with amyotrophic lateral sclerosis.

Resolution was approved by VFW Post 2894 membership at their meeting of 10 November 2021.



+ DECEMBER SAFETY CORNER + Buzzed Driving Is Drunk Driving

This holiday season, be safe on the roads, traveling to and from get-togethers and vacation destinations. If you plan to go out and include alcohol in your celebration, make sure you refrain from driving. Review these facts and spread the word about the dangers of drunk driving.

Buzzed Driving: The Sobering Statistics

• 837 people lost their lives in traffic crashes involving a drunk driver in December 2019.

• During the Christmas and New Year's Day holiday periods in 2019 alone, there were more drunk-driving-related fatalities (210) than during any other holiday period that year.

• In 2019, there were 10,142 people killed in drunk-driving crashes; one person every 52 minutes.

• Nighttime is a particularly dangerous time to be on the roads: The rate of (alcohol impairment among drivers



involved in fatal crashes in 2019 was 3.3 times higher at night than during the day.

The Cost of Drunk Driving

• On average, a DUI can set you back \$10,000 in attorney's fees, fines, court costs, lost time at work, higher insurance rates, and more.

• Impaired-driving crashes cost the United States \$44 billion annually.

• If you're caught drinking and driving, you can face jail time. Imagine trying to explain that to your friends and family or your place of employment.

• Drinking and driving can cause you to lose your driver's license and your vehicle. This could inhibit you from getting to work, resulting in lost wages and, potentially, job loss.

Celebrate with a Plan

Always remember to plan ahead if you will be celebrating. If you plan to drink, plan ahead for a sober driver to take you home. Is it your turn to be the designated driver? Take that role seriously and do not consume alcohol, not even one drink.

• Remember that it is never okay to drink and drive. Even if you've had only one alcoholic beverage, designate a sober driver or plan to use public transportation or a ride service to get home safely.



• If you see a drunk driver on the road, contact Local Law Enforcement.

• Do you have a friend who is about to drink and drive? Take the keys away and make arrangements to get your friend home safely.
