

In a heartwarming display of unity and support, area community organizations have joined hands to assist a Gold Star mother in her time of need. Virginia Foundation Solutions, commonly known as VFS, the Veterans of Foreign Wars (VFW) Post 2894, Habitat for Humanity of South Hampton Roads, and Home Depot came together to make a profound difference in the life of a military family who has given so much for our nation.

In early August 2023, Ms. Carrie Caldwell, a local Gold Star Mother, contacted Chesapeake VFW POST 2894 Service Officer Jim Ireland, who a few years earlier had helped her with repairs to her house. She stated that her kitchen floor had soft spots and she needed help to repair it. Jim reached out to a good friend and fellow humanitarian, Frank Hruska, CEO, Habitat for Humanity South Hampton Roads, for help. The two went to Ms. Caldwell's house and crawled underneath to inspect her kitchen foundation. It was quickly apparent that the foundation needed to be repaired or replaced. Frank volunteered to replace the flooring but only after a professional foundation repair company could repair or replace the failing foundation.

Jim appreciated Frank's offer, but realized it meant nothing was going to happen unless he could find a professional foundation repair company that would take on such a costly project at a cost the VFW Post could afford. He decided to call Carolyn Farris, General Manager of the Virginia Foundation Solutions, a solid, veteran-owned company that he hoped and

prayed would help. After explaining the magnitude of the project and that it was for a Gold Star Mother who had lost her son in the first Gulf War, without hesitation Virginia Foundation Solutions agreed to help and would donate the labor and materials at no cost.

Jim then called Mr. Greg Hyatt, District Outreach Manager for Home Depot, requesting flooring for Ms. Caldwell's kitchen as well as any other supporting items needed for the floor installation. Greg stated he would gladly assist the project and to pick up the items needed from two local Home Depot stores.

The team was now in place and on 16 October 2023 the work started with the Virginia Foundation Solutions workers showing up to Ms. Caldwell's house in force, quickly removing the kitchen cabinets, countertops, sink, hot water heater, and appliances. Then the serious work began with the meticulous removal of the old flooring and rotten foundation. This was followed by rebuilding the foundation from the ground up. Virginia Foundation Solutions rebuilt the entire support structure including beams, joists, and new subflooring. All was completed in less than three days.

After the completion of the foundation repairs, the Habitat for Humanity workers arrived and replaced all the cabinetry, countertops and appliances. They repaired the leaking sink and numerous other leaks throughout the kitchen plumbing and laid the new kitchen floor. The entire project was completed in six days. Lastly, the kitchen floor was installed.

The collaborative efforts of these organizations demonstrate the power of community and the incredible impact that can be made when people come together for a common cause. This story is a beautiful example of the importance of communities throughout this nation. The Chesapeake community paused their daily routines and focused their attention on a project to show their respect for a fallen service member of their community who gave his life for the freedoms they/we all enjoy, each, and every day and offer help to this family in need. It is what makes America a great place to live and raise our families. Communities make a difference.

• VFW Post 2894 Coordinates Repairs for Vietnam Veteran's Widow. In June of 2022, VFW District 2 Service Officer and Chesapeake Post 2894 member, Gary Dunbar approached Jim Ireland, the VFW Post 2894 Service Officer, and said he had discovered a Vietnam widow in his neighborhood whose house looked like it was in dire need of repair, especially the roof. Jim and Gary went to this lady's house, Ms. Addie Rawls, knocked on her door and informed her of their VFW association and asked if she was having issues with her home. They quickly discovered that her roof and windows were in terrible condition, but she did not have the money to repair them. Her home needed much more work, but the only thing that worried her were the roof and windows. Due to her income and military widow status, the Service Officers felt she might qualify for a grant from Habitat for Humanity of South Hampton Roads (SHR). This organization is a very veteran friendly local enterprise that recently developed a program to repair homes, not just build them. They are always ready to help a veteran in need if they can.

Having success with similar past projects, Jim approached the organization to see if they would be willing to help Ms. Rawls repair her roof. Unfortunately, the year's list (2022) was full and they could not provide assistance at that time. However, a Habitat for Humanity SHR representative said they would put her at the end of their 2022 list and if they could not get to her in 2022, which they could not, she would be a candidate for next year when additional funds became available.

As fate and patience would have it, the following year in late October 2023 Habitat for Humanity SHR was able to replace her

roof at no cost (over \$10,000). Additionally, they were trying to replace her windows but due to the roof being in such bad shape and costing more than anticipated, they did not have enough remaining funds to complete the window replacement. However, Habitat for Humanity SHR is currently looking for other sources of funding that she could use to do her windows. They said that if she could not find the funding, she will be eligible in two years for another grant from them and they will come back and do her windows. What a godsend for this widow!

This is only one story of the great work Habitat for Humanity SHR does in working with our VFW Post to assist veteran families. The looks and smiles on these veteran widows and widowers' faces, knowing they can live out their remaining years on this earth in a safe, warm home, is priceless!

• VFW Post 2894 Coordinates Window Replacement for Virginia Beach Veteran. In mid-October 2023, Jim Ireland, the VFW Post 2894 Servicer Officer, received a call from the Quartermaster of VFW POST 392 in Virginia Beach, Virginia, requesting help for a veteran family in the city that was a time sensitive situation. Their key personnel were not available to help in a timely manner.

Jim agreed to assist the Lee family and called them to get the details. Ms. Lee informed Jim that her husband had a heart attack recently and was not able to work due to many other medical issues. Because every window in their house was rotted and the wind constantly blew through them, her main concern was for the health of her husband, so she was hoping that the windows could be repaired or replaced. With winter approaching and with her husband in a weakened condition, she was concerned he could contract pneumonia and potentially die. Their income was not enough to allow for the replacement of the fifteen windows in the house and they were struggling just to make enough money to pay their bills.

Jim contacted "Window World," an award-winning veteran friendly and supportive business whom he had worked with in the past and who has helped other veterans in need. Jim met with a Window World representative at the Lee's house where the damage to the windows was assessed. The representative informed the Lees that Window World would indeed help by replacing all fifteen windows at no cost to the veteran (an estimated \$16,000 plus project).

Understanding the medical urgency of the matter, Window World went to work immediately and within three weeks had completed the construction of the windows. They had beaten the winter wind and cold with an exceptional quality job. It may not have been a miracle to some, but one would be hard pressed to convince Mrs. Lee because her prayers were answered!

Thanks to Window World's generosity and sense of urgency, Mr. and Mrs. Lee can feel safe and protected from the elements during the upcoming winter season and in so doing provide a healthy environment for the healing of Mr. Lee.

This is again just one more story of the great people and organizations in this country that understand the meaning of giving back, especially when it involves a medical necessity and especially when it is for a veteran! Giving back usually comes back to you in a much more rewarding way than it was given!

POST MEMBER MEETS MEDAL OF HONOR WINNER

VFW Post 2894 Comrade Kimball Thompson, a member of the local Virginia Society of the Sons of the American Revolution, was a member of the color guard detail for a recent Gold Star Family event. Kimball had the honor of meeting Captain Gary Michael Rose, U.S. Army (retired), a Medal of Honor awardee who was attending the event. A sergeant at the time, Rose received the MOH for his courageous actions in Vietnam during a four-day encounter with the enemy in September 1970 while serving as a Special Forces medic. Sgt Rose was recognized for

saving numerous lives during a four-day ordeal while himself being wounded several times. The citation reads thus: "For conspicuous gallantry and intrepidity at the risk of his life above and beyond the call of duty:

"Sergeant Gary M. Rose distinguished himself by acts of gallantry and intrepidity while serving as a Special Forces Medic with a company-sized exploitation force, Special Operations Augmentation, Command and Control Central, 5th Special Forces Group (Airborne), 1st Special Forces, Republic of Vietnam. Between 11 and 14 September 1970, Sergeant Rose's company was continuously engaged by a well-armed and numerically superior hostile force deep in enemy-controlled territory. Enemy B-40 rockets and mortar rounds rained down while the adversary sprayed the area with small arms and machine gun fire, wounding many and forcing everyone to seek cover. Sergeant Rose, braving the hail of bullets, sprinted fifty meters to a wounded soldier's side. He then used his own body to protect the casualty from further injury while treating his wounds. After stabilizing the casualty, Sergeant Rose carried him through the bullet-ridden combat zone to protective cover. As the enemy accelerated the attack, Sergeant Rose continuously exposed himself to intense fire as he fearlessly moved from casualty to casualty, administering lifesaving aid. A B-40 rocket impacted just meters from Sergeant Rose, knocking him from his feet and injuring his head, hand, and foot. Ignoring his wounds, Sergeant Rose struggled to his feet and continued to render aid to the other injured soldiers. During an attempted medevac, Sergeant Rose again exposed himself to enemy fire as he attempted to hoist wounded personnel up to the hovering helicopter, which was unable to land due to unsuitable terrain. The medevac mission was aborted due to intense enemy fire, and the helicopter crashed a few miles away due to the enemy fire sustained during the attempted extraction. Over the next two days, Sergeant Rose continued to expose himself to enemy fire in order to treat the wounded, estimated to be half of the company's personnel. On September 14, during the company's eventual helicopter extraction, the enemy launched a full-scale offensive. Sergeant Rose, after loading wounded personnel on the first set of extraction helicopters, returned to the outer perimeter under enemy fire, carrying friendly casualties and moving wounded personnel to more secure positions until they could be evacuated. He then returned to the perimeter to help repel the enemy until the final extraction helicopter arrived. As the final helicopter was loaded, the enemy began to overrun the company's position, and the helicopter's Marine door gunner was shot in the neck. Sergeant Rose instantly administered critical medical treatment onboard the helicopter, saving the Marine's life. The helicopter carrying Sergeant Rose crashed several hundred meters from the evacuation point, further injuring Sergeant Rose and the personnel on board. Despite his numerous wounds from the past three days, Sergeant Rose continued to pull and carry unconscious and wounded personnel out of the burning wreckage and continued to administer aid to the wounded until another extraction helicopter arrived. Sergeant Rose's extraordinary heroism and selflessness above and beyond the call of duty were critical to saving numerous lives over that four day time period. His actions are in keeping with the highest traditions of military service and reflect great credit upon himself, the 1st Special Forces, and the United States Army."

OPERATION LINEBACKER II – BOMBING OF NORTH VIETNAM IN DECEMBER 1972

During what would become the closing days of the Vietnam War, American troops were in the middle of the biggest bombing mission in military history during the Christmas season of 1972. The air campaign, called Operation Linebacker II, is largely considered to be the action that ended U.S. involvement in the Vietnam War.

President Richard Nixon ordered the bombings to begin on Dec. 18 after North Vietnamese delegates walked out on peace talks. Nicknamed the "11 Days of Christmas,"the operation consisted of 11 successive days of raids by B-52 Stratofortress bombers flown in from Andersen Air Force Base in Guam.

The only day that both sides got a reprieve was Christmas, when troops were given a 36-hour break to celebrate. During that time, Nixon ordered the North Vietnamese to return to the bargaining table. The North Vietnamese refused, so the bombings continued until Dec. 29, when they agreed to resume peace talks.

In eleven days, Linebacker II dropped 15,000 tons of bombs via 729 U.S. Air Force sorties involving about 12,000 airmen. Defense Department records show the raids destroyed or damaged 1,600 structures, 500 rail targets, ten airfields and eighty percent of North Vietnam's electric-generating capacity. Fifteen U.S. B-52s were also destroyed in the process, killing 35 men and leading to the capture of nearly 40 American prisoners of war.

The resumed peace talks that came from the campaign led to the Paris Peace Accords in January 1973. The U.S. ended its involvement in the war soon after, but the last American troops wouldn't leave the country for another two years.

★ SAFETY CORNER ★DECEMBER IS SNOW AND ICE SAFETY MONTH



As cold weather sets in, and snow or ice follows, we must prepare to move about safely. The CDC reports that approximately one million adults are injured due to slips and falls every year. In fact, the colder the environment, the higher the injury rate, especially among older adults (like some of us).



There are several steps you can take to reduce your chance of a debilitating injury from a fall, or even a minor one:

- Wear proper footwear during snowy or icy conditions; lightweight boots with good ankle support are recommended.
- Take your time and walk slowly. Wisely look ahead for dangerous areas and choose your path carefully.
- When possible, use assistance while walking, such as handrails, a cane, or walking sticks.
- Take small steps; maintain a solid center of gravity with your feet slightly spread. Walk like a penguin, with a slight waddle.
- If you fall, do not catch yourself with your arms ... this
 only increases your chances of injury. Fall onto your buttocks or back. Once you recover, wait for assistance to get
 up if you can. If none is available, work yourself to an upright position slowly and carefully.

A good tip to decrease your chance of falling is to stay inside if you do NOT need to go out during snowy or icy conditions. Stay safe. We want to see you at our next meeting.

During this time of year, the most common hazards and the greatest number of injuries are from motor vehicle accidents.

WHAT IS THE SCOUT OF THE YEAR PROGRAM?

Annually, the Veterans of Foreign Wars of the United States recognizes individuals who are: Eagle Scouts, Girl Scout Gold Award recipients, Venture Summit Award recipients and/or Sea Scout Quartermasters who have risen above their peers in exemplifying the qualities of that rank.

AMIFLIGIBLE?

To be eligible for the award, the candidate must:

- Be the recipient of the Eagle Scout Award, Girl Scout Gold Award, Venture Summit Award or Sea Scout Ouartermaster Award.
- Be a registered, active member of a Boy or Girl Scout Troop,
 Venturing Crew or Sea Scout Ship at the time the above reward was received.
- Have demonstrated exemplary citizenship in school, Scouting and community.

Prior National Scout of the Year winners are ineligible. There is no minimum age requirement for applicants as long as all other eligibility criteria has been met. The maximum age requirement for applicants is 18 years old. If an applicant reaches their 18th birthday during the nomination year, they remain eligible as long as they are still in high school at the time of the submission deadline. A Scout may enter through only one VFW Post. A local Post can be identified by zip code at vfw.org/FindaPost.

WHAT ARE THE DEADLINES?

- Deadline for entry to VFW Post is <u>March 1</u>.
- One candidate with full entry criteria must be submitted by a VFW Post to the next level of judging by <u>April 1</u>. The VFW Department Scouting chairman can provide this information.
- The Department winner must be selected and submitted by their Department Scouting chairman to the VFW National Headquarters by May 1.
