League Play is a single trial held over a period of four dates over a four-week period. Our dates will be Friday evenings, August 9, August 23, September 6 and September 20.

You may pick and choose which dogs, which weeks and which rounds to enter. Only one dog per round. There will be no resets available.

Move ups available week to week with proper written request to host. Requests must be submitted by the Tuesday prior to the weekly search.

Classes are judged by a C-WAGS judge and trial results are submitted at the end of the league (trial). Scores earned during League will be credited as of the last day of the league.

*Early bird entry is granted to daycare clients And students enrolled in classes at See Spot Run. A valid registration includes the completed entry form and signed waiver with payment. (If choosing paypal, invoices will be sent once entry is received)

Female dogs in season (BIS) may be allowed to compete upon approval of restrictions. A BIS will only be able to run as the last dog of the last class. Contact Anneli to discuss options should your dog come into season during league.

This trial is open to reactive dogs.

Location & Directions: The trial will be held at See Spot Run Doggy Daycare & Training Inc., 7715-69 Street, Edmonton, AB

Schedule: The searches will begin between 6:15 - 6:30 pm. Searches will run consecutively and simultaneously. For handlers who are switching dogs between rounds it will be accounted for in the running order.

League Specific Rules

- 1. Choose which dogs, which weeks and which rounds you want to enter by completing the attached entry form.
- 2. Registration form must be completed with the information for all dogs being entered.
- 3. You do not need to enter every week.

CWAGS Notice To Exhibitors

Competitors, through submission of entry, acknowledge that they are knowledgeable of C-WAGS Obedience & Rally rules and regulations including but not limited to the following rules regarding entry:

- All exhibitors are expected to treat the judges, trial hosts, your canine partner and all other exhibitors with respect.
- All judges and trial hosts are expected to show respect to all exhibitors.
- This trial is open to all dogs registered with C-WAGS.
- Trial Hosts may elect to accept FOR EXIBITION ONLY entries of nonregistered dogs.
- Teams may be entered in multiple levels/classes at the same trial.
- Dogs must be shown by a member of the owner's immediate family.
- Collars: The dog must wear a flat type collar (buckle, snap or proper fit martingale) and/or body harness in the ring. Electronic training collars are not allowed on the show grounds.
- Owners with disabilities are encouraged to compete. Any necessary modifications to the exercises must be provided by the handler to the judge and approved by the judge.
- Safety shall always be of foremost consideration in actions and conduct by handlers at all times. Handlers, through entry at this event, accept full responsibility for themselves and the actions of their dogs.

In addition,

- The organizing committee may refuse any entry for any reason.
- THERE SHALL BE NO REFUND for entries in the event a dog and/or handler are dismissed from competition, regardless of reason for such dismissal.
- Refunds will be made for females in season upon written request accompanied by a statement from the exhibitor's veterinarian.
- Any fees not received within 7 days of notice result in cancellation of event results for all classes for the registration number(s) of delinquent entry/entries. No reinstatement of results is possible.
- All competitors through entry at this event waive any and all rights relative to video broadcast of this event. Competitors shall have the right to videotape portions of this event for their personal use only. No portion of this event may be videotaped for commercial or other purposes.
- Dogs must be on leash while on show grounds unless being shown.
