League Play is a single trial held over a period of six dates within a 2 month period. Think bowling league. Our dates will be Friday evenings, January 8, January 15, January 29, February 5, February 12 and February 19.

There will be two streams to join. The Beginner League will cover Level 1, Level 1 Ranger and Level 2. The Advanced League will cover levels that require a title in previous levels in order to play. Advanced League will have Level 2 Ranger, Level 3 and Level 4. Over the six week duration each level will be played twice. If you dog is eligible to play in both streams you may enter either or both if you wish and have two searches each week. Resets will be offered.

Classes are judged by a C-WAGS judge and trial results are submitted at the end of the league (trial). Scores earned during League will be credited as of the last day of the league.

CWAGS registration for your dog is required.

Entries Close: **December 15, 2020 or when full**

A valid registration includes the completed entry form and signed waiver with payment. (If choosing paypal, invoices will be sent once entry is received)

Entries are limited to 1 dog per handler per stream. Reset for second dog of same handler will be available.

Female dogs in season may not compete.

This trial is open to reactive dogs.

Location & Directions: The trial will be held at See Spot Run Doggy Daycare & Training Inc., 7715-69 Street, Edmonton, AB

Schedule: Beginner stream will start no earlier than 6:30

Advanced Stream will follow Beginner stream (prior to resets)

Approximately 7:30 or earlier based on elapsed search time.

Resets will follow in order.

League Specific Rules

1. Limited entry. There will be 20 spots available per stream plus resets.
2. Choose to enter Beginner Stream or Advanced Stream. Entering both is an option if dog is qualified. Resets will be available to second dogs of same handler and judges.
3. Registration form must be completed for each dog and stream.
4. League play is a 6 week commitment. If for some reason you are unable to attend a week, you will forfeit your searches for that evening.
5. Ribbons will be awarded the following week once results are tabulated.
6. Results will be submitted to CWAGS at the end of the six week period.
7. In the event of drastic winter weather, an evening may be cancelled and added to the end of the six week period.
