In the hopes of making the process of entering our trials a bit easier this season, all trials for the month will open on the 1st of the prior month. You may send all trial entries for the month in one envelope but each entry will require a separate cheque.







Limited Entry Rules

The process of accepting entries for this trial will be:

- Only mailed, couriered or hand delivered entries will be accepted.

 No email entries will be accepted.
- Please complete a separate entry for each dog to be entered.
- For an entry to be valid it must contain both pages of the form, entry and signed General Agreement.

 Incomplete entries will not be accepted.
- Entry fees are to be payable to **Deb Rhodes.** Cheques may be posted date no later than the closing date of the trial
- Entries will be accepted based on the postmark date or delivery date stamp if hand delivered. Should the trial fill with entries of the same date, priority will be given to those that volunteer at Mut Hut Agility trials. Any remaining entries will be put into a random draw to fill the trial.
- NEW Entries for an entire month can be sent in one envelope on the opening day. THERE MUST BE A SEPARATE CHEQUE FOR EACH TRIAL.

Only entries received on or after **June 1, 2020** and on or before **July 24, 2020** will be accepted.

Class Changes

A dog that has entered a trial and subsequently earns a title shall be permitted to move up in that class, as long as the trial secretary is notified at least **one week** prior to the date of the trial. If you do not contact the trial secretary, you may not be permitted to move up on the day of the trial. **Please check your confirmations to ensure you are entered in the proper class.**







Directions to Rhodes Acreage (21112 Twp Rd 524, Ardrossan)

Directions from Edmonton Hwy 16 – Go east on Hwy 16 until you hit Range Road 211. Go south (right) on Range Road 211 until you reach TWP Road 524. Head west on TWP Road 524 until see the marked driveway for the Rhodes Acreage on the right. Please park in the designated parking area.

Directions from Edmonton Anthony Henday – Take exit for Hwy 628 (TWP Road 522) going east. Head east until you come to Hwy 21. At the intersection, go north (left) onto Hwy 21. Drive north on Hwy 21 until you get to the intersection of Wye Road (Hwy 630). At the intersection, turn east (right) onto Hwy 630. Continue east until you get to TWP 524 and turn left. (Look for sign to Uncas School). You will cross train tracks shortly after turning left. The road will bend slightly to the right and then straighten again. Stay on TWP Road 524 until you see a marked driveway for the Rhodes Acreage on the left. Please park in the designated parking area.

Agility Class Descriptions

Regular Classes: These classes are open to all dogs, 18 months of age or older, as described within the current AAC rules. **Special Classes:** These classes are open to all dogs but are intended for dogs that are of a size or stature that limits there jumping ability. A dog may no longer compete in Regular classes after being entered at an official trial in any Special class except that they may move to Veterans.

Veterans Classes: These classes are for dogs seven years of age or older that are currently competing in any Standard Agility Class and for dogs five years of age or older who have competed in the Specials Agility Class for a minimum of one calendar year. **Junior Handlers:** We are pleased to offer junior handlers classes. The AAC has expanded the Junior Handlers program to allow juniors to run in and earn qualifying scores in all classes, including games. Juniors will have veteran times and may run at a height lower than that at which the dog normally competes, and can accumulate their qualifying scores with different dogs.

Starters Games Classes: The Starters Games Classes are for dogs that have not completed two clear rounds in that particular game under two different judges.

Advanced Games Classes: The Advanced Games Classes are for dogs that have not completed three clear rounds in that particular game under two different judges.

Masters Games Classes: The Masters Games Classes are for dogs that have fulfilled the requirement of achieving three clear rounds in each particular game under two different judges.

Starter Standard Class: The Starters Class is for dogs not having earned the Agility Dog of Canada (ADC) title. Dogs completing three (3) clear rounds of Starters Standard, as defined by the AAC Rules and Regulations, shall be awarded the ADC title.

Advanced Standard Class: The Advanced Class is for dogs not having earned the Advanced Agility Dog of Canada (AADC) title. Dogs completing three (3) clear rounds of Advanced Standard, as defined by the AAC Rules and Regulations, shall be awarded the AADC title.

Masters Standard Class: The Masters Class is for dogs not having earned the Masters Agility Dog of Canada (MADC) title. Dogs completing three (3) clear rounds of Masters Standard, as defined by the AAC Rules and Regulations, shall be awarded the MADC title.

Steeplechase: The Steeplechase class demonstrates the dog's ability to run and jump at speeds while maintaining control on the Aframe and weave poles and is open to all dogs eligible to compete in AAC events at any level.

Challenge: This class is only open to dogs competing in Masters Standard class and tests both handling skills and speed.

Team Relay: This class is open to all dogs eligible to compete in other AAC qualifying events at the Starters, Advanced or Masters levels. This game demonstrates team spirit, strategy and sportsmanship.







Notice to Exhibitors

Exhibitors, through submission of entry, acknowledge that they are knowledgeable of the rules and regulations of the AAC, including but not limited to the following:

- > This event is held under AAC Rules and Regulations and is open to all dogs being at least 18 months of age, pure breed or mixed breed, except bitches in season, aggressive dogs, or dogs suffering from any deformity or illness which may affect the dog's physical or mental performance.
- > Obstacles shall be chosen from those described in the current edition of the rules and regulations of the AAC and shall conform to AAC specification.
- No leads, collars, food or any other aids or devices shall be permitted on the course at any time.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and / or children. Any exhibitor whose dogs and / or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may be asked to leave the trial site and NO REFUND of fees shall be given.
- All dogs must be penned, crated or attended on leash when not in the ring. All dogs must be under control when exiting the ring. Any dog engaging in aggressive or out of control behavior upon exit of the ring may be disqualified and / or required to leave the trial site and NO REFUND of fees shall be given.
- **Bitches in season are not allowed on trial property.**
- Exhibitors MUST keep crate and exercise areas clean. Please clean up after yourselves and your dogs. Anyone who does not clean up after themselves or their dogs may be required to leave the trial site and NO REFUND will be given.
- ➤ Refunds, cancellations or changes after the closing date, will be subject to a \$10 administration fee (except for bitches in season or injured dogs with a certificate from a veterinarian) providing the trial secretary is informed prior to the trial date.
- ALL DOGS MUST HAVE AN AAC ID CARD AND NUMBER TO COMPETE IN AN AAC TRIAL. If your dog does not yet have an AAC ID card, please registration with AAC at www.aac.ca.
- > The trial site is outdoors on a grass surface in a fully fenced ring.

The Trial Committee has the right to refuse any entry for causes which they deem sufficient. Please check your entry before sending to ensure all required information has been completed, including dog's ID number, class and correct jump height. Incomplete entries will not be accepted. The "General Agreement form" must be signed and included with your entry in order to comply with AAC's acceptance to this trial.
