League Play is a single trial held over a period of four dates over a six-week period. Our dates will be Friday evenings, Apr 11, Apr 25, May 2, May 23 and May 30.

You may pick and choose which dogs, which weeks and which rounds to enter. Only one dog per round. **There will be no resets available.**

Move ups available week to week with proper written request to host. Requests must be submitted by the Tuesday prior to the weekly search.

Classes are judged by a C-WAGS judge and trial results are submitted at the end of the league (trial). Scores earned during League will be credited as of the last day of the league.

Early Bird Entries Open: March 5, 2025 @ 9:00 am and close March 21, 2025 @noon

Regular Entries Open: **March 22/25 @ 9:00 am**

Entries Close: **April 2/25 @ noon or when full**

**Early bird entry is granted to daycare clients and students enrolled in classes at See Spot Run.*

NEW ENTRY PROCESS

All entries will be processed online through Agility Rocks. You can Access the entry on opening day at <https://agilityrocks.com/>.

- Each week of league will be done as a separate entry. You can send one e-transfer for the entire league.
- If you qualify for early bird access, you will be provided a code via email to enter on early bird date.
- Once the maximum number of runs per class is reached those runs or the trial will be full. You can email the trial secretary to be put on the waiting list.
- If you need to enter multiple dogs, **DO NOT HIT THE SUBMIT BUTTON** until **ALL** dogs have been entered. Once your entry is submitted, it cannot be added to or edited.
- If you do not already have an account with Agility Rocks, it is highly recommended that you take the time to set up one prior to the trial opening date. See AGILITY ROCKS Instruction sheet attached.

PAYMENTS

Once you have entered, please e-transfer your entry fees to trials@seespot-run.com. No password is required. Please put a note on your transfer that is for CWAGS League. Payment must be received within 24 hours of entry to be valid.

League Specific Rules

1. Choose which dogs, which weeks and which rounds you want to enter by completing the attached entry form.
2. Registration form must be completed with the information for all dogs being entered.
3. You do not need to enter every week.
4. Ribbons will be awarded the following week once results are tabulated.
5. Results will be submitted to CWAGS at the end of the four-week period.

Schedule: The searches will begin between 6:15 - 6:30 pm. Searches will run consecutively and simultaneously. For handlers who are switching dogs between rounds it will be accounted for in the running order.

Female dogs in season (BIS) may be allowed to compete upon approval of restrictions. A BIS will only be able to run as the last dog of the last class. Contact Anneli to discuss options should your dog come into season during league.

This trial is open to reactive dogs.

CWAGS Notice To Exhibitors

Competitors, through submission of entry, acknowledge that they are knowledgeable of C-WAGS Obedience & Rally rules and regulations including but not limited to the following rules regarding entry:

- ♦ All exhibitors are expected to treat the judges, trial hosts, your canine partner and all other exhibitors with respect.
- ♦ All judges and trial hosts are expected to show respect to all exhibitors.
- ♦ This trial is open to all dogs registered with C-WAGS.
- ♦ Trial Hosts may elect to accept FOR EXIBITION ONLY entries of non-registered dogs.
- ♦ Teams may be entered in multiple levels/classes at the same trial.
- ♦ Dogs must be shown by a member of the owner's immediate family.
- ♦ Collars: The dog must wear a flat type collar (buckle, snap or proper fit martingale) and/or body harness in the ring. Electronic training collars are not allowed on the show grounds.
- ♦ Owners with disabilities are encouraged to compete. Any necessary modifications to the exercises must be provided by the handler to the judge and approved by the judge.
- ♦ Safety shall always be of foremost consideration in actions and conduct by handlers at all times. Handlers, through entry at this event, accept full responsibility for themselves and the actions of their dogs.

In addition,

- ♦ The organizing committee may refuse any entry for any reason.
- ♦ THERE SHALL BE NO REFUND for entries in the event a dog and/or handler are dismissed from competition, regardless of reason for such dismissal.
- ♦ Refunds will be made for females in season upon written request accompanied by a statement from the exhibitor's veterinarian.
- ♦ Any fees not received within 7 days of notice result in cancellation of event results for all classes for the registration number(s) of delinquent entry/entries. No reinstatement of results is possible.
- ♦ All competitors through entry at this event waive any and all rights relative to video broadcast of this event. Competitors shall have the right to videotape portions of this event for their personal use only. No portion of this event may be videotaped for commercial or other purposes.
- ♦ Dogs must be on leash while on show grounds unless being shown.

AGILITY ROCKS ACCOUNT SET UP

Agility Rocks is mainly used for online agility entries, but we do have the ability to use it for our CWAGS trail entries as well. There will be steps for those who have an agility profile and those that don't. **Please make sure you follow the correct method based on your account.**

- A) If you have an Agility Rocks AAC agility profile for your dog
 - a. Make sure you have checked the "Show me the AAC trials" checkbox.
 - b. When you go to enter the scent detection trial make sure to enter your CWAGS number in the entry notes.**

- B) If you are new to Agility Rocks and don't play agility
 - 1. Go to agilityrocks.com and sign in. If you do not already have an account, create one. If you do not receive the confirmation email, check your spam/junk folder. If you still don't see it, or if you have any errors confirming your email, please contact support@agilityrocks.com.
 - 2. After registering, enter your dog on your account. Enter your dog's call name, breed, birthdate, and sex. Check the "Show me the AAC trials" checkbox.
 - a) If you do not play AAC agility trials, enter your dog's CWAGS number in the AAC ID number box, and pick the 8" height division. **When you go to enter the scent detection trial make sure to enter your CWAGS number in the entry notes.**
