**SET UP 6:30AM-9:00AM (vehicles must be moved from the square by 9:00AM)**

**\*\*\* ALL VENDORS MUST CHECK IN AT THE INFORMATION TENT (SOUTHEAST CORNER OF THE SQUARE) TO RECEIVE YOUR BOOTH NUMBER & OFFICIAL TICKET \*\*\***

- Booth size is 10x10
- Booth fee is \$25 per 10x10 or \$25 per 10 ft of trailer.
- Fundraisers are \$12.50 per 10x10 space. LOCAL ARMSTRONG COUNTY OR CLAUDE FUNDRAISERS (non-profit, school, church, club) ARE FREE (NO FEE).
- Trailer spaces are limited. Please call ahead to verify available space. All trailers are \$25 per 10ft length.  
*Important: Be sure to include length on entry form.*
- Booths are assigned on a first come, first served basis. Similar booths will be kept separate. We do our best not to duplicate certain vendors. Only 1 MLM representative per company (Scentsy, Lula Roe, etc.).
- Booth assignments will be given the morning of the event at the Information Tent (Southeast Corner of the Square) unless prior arrangements have been made with Tessa Waddell or Gena Ray.
- Booth set up is 6:30am- 9:00am on the morning of the event. All vehicles must be moved from the Courthouse Square area by 9:00 am or risk being towed at owner's expense. The square and adjacent roads will be closed to vehicles at 9am for the parade and will be closed all day until 4pm.
- Portable toilets, food and drink vendors will be on site.
- Booth fee includes space only, NO ELECTRICITY, NO WATER, NO CHAIRS, NO TABLES. Vendors must provide their own tables, chairs, awnings and set up.
- Each organization/individual/vendor will be completely responsible for set up/take down of their booth and trash pick-up around their booth.
- NO DUMPING SALTWATER (from Ice cream freezers, etc.) on grass or anything else that could harm the grass
- Sales tax in Claude is 8.25%. Vendors are responsible for the collection and reporting of taxes. The Claude Chamber of Commerce is not responsible for the collection or reporting of taxes.
- Vendors/Exhibitors are responsible for manning their own booths from 9am until 4pm, unless you sell out.
- The Claude Chamber of Commerce is not responsible for loss or accidents. \*See agreement on entry form\*
- Returned checks will incur a \$25 returned check fee.
- **NO REFUNDS for cancellations or inclement weather, wind or other uncontrollable circumstances.**
