Cornerstone Kids Preschool does not charge a Registration or Curriculum Fee for <u>VPK Free children</u> from 9:00 am to 12:00 noon, but if the child needs to expand outside of Free VPK from 9:00am -12 noon, they pay a rate that includes a \$150 Registration and \$150 Curriculum Fee paid as you use the service

VPK Attendance Policy: There are 180 mornings= 540 hours of VPK Instruction in our VPK Program.

The State VPK 80/20 attendance policy as set forth by the Early Learning Coalition throughout Florida: VPK funds are paid on a daily basis for the child whose attendance remains at 80% or above for monthly class attendance & for the entire year of attendance. When a child falls below 80% (144 days) attendance through the year, it means they have missed 20% (36 days) of Instruction and thus, the child loses the FREE program. As with any VPK provider in Florida, we pursue payment for our program when the child steps outside of Free VPK and chooses to continue the year in our Non-VPK Four Year Old Program. Therefore at 20, 25 & 30 days missed, our Director will check in with the parent to discuss our VPK Attendance policy. On the 37th day of absence, the parent is charged \$35 per day every day thereafter for the child to complete their pre-school year.

Every absence is counted. There are no excused absences. Please monitor your child's attendance to attend more than 80%. It is important that all children who start VPK complete it.

VPK attendance is taken seriously and is a partnership between VPK parents and Cornerstone Kids Preschool. If you feel that you will not be able to support more than 80% attendance for your child, you may opt to participate in our non-VPK program as space is available.
