## **Registration:**

Make the following cheques payable to "SMCSS":

- 1. Registration Fee: \$50.00 per child
- 2. Volunteer Deposit: \$200.00 per family\*
- 3. Instrument Rental Fee: \$50.00 for 1<sup>st</sup> and \$10.00 for each additional instrument
- 4. Instrument Damage Deposit: \$150.00 per instrument\*

### \*Deposit cheques (2 of the above) to be post-dated to June 1 of the following year.

- There are no additional fees for group lessons or orchestra rehearsals.
- Registration and Rental Fees are refundable only if the private lessons cannot be arranged.
- Cheques returned from the bank for any reason, including Non-Sufficient Funds, shall be subject to a charge of \$20.00

### **Conditions of Registration:**

I have read and agree to the following conditions of registration:

- I recognize that post-dated cheques are a method of payment for annual tuition fees and agree that I will not stop payment if I choose to withdraw from the society.
- I understand that there is no refund for Registration Fees (this provision does not apply to Pre-Registration Fee specified on the 1<sup>st</sup> page).
- Should I choose to withdraw my child(ren) from the program, I will provide 30 days written notice to the SMCSS. If written notice is not given, I agree to forfeit one month's private, and the remainder of the group lesson fees for that registered term.
- Should I choose to withdraw my child(ren) from the program, I will surrender rental instrument(s) and/or supplies belonging to the society upon departure from the program.
- I understand that if a student is absent from a group lesson for any reason whatsoever, there is NO REFUND for that missed lesson. If a teacher cancels a group lesson, he/she has the option of making up the lesson at a later time or arranging for a substitute.
- I understand that if I cancel a private lesson, I am required to provide the teacher with a minimum of 24 hours prior notice. Such cancellations will be made up at the teachers' discretion. After 2 failed attempts to reschedule such a lesson in 30 days, the lesson will be forfeit. In the event of serious illness, serious injury or family crisis, the lessons will be made up without question or the teacher will arrange for a refund. Refunds will be issued upon completion of the fiscal year which occurs on June 30 of each calendar year.
- Any private lessons cancelled by the teacher will be automatically made up or refunded by June 30 of that program year.
- Cheques returned from the bank for any reason, including Non-Sufficient Funds, shall be subject to a charge to a charge of \$20.00.
- Should I choose to keep a rental instrument over the summer break, the child must be pre-registered by June 30. Otherwise, the instrument must be returned to the society by June 30.
