(ALL Hereinafter referred to as "the Photographer")

Whereas for valuable consideration hereby acknowledged as received, the Model granted the Photographer permission to photograph and/or film and sound record the Model and furthermore grant permission to use the resulting work ("the Work") according to the terms stated hereunder:

Any permission granted to the Photographer shall extend to his/her successors, legal representatives, licensees and assigns and shall be irrevocable and perpetual without any further or additional claim for compensation by the Model.

Use of the Work shall be unrestricted as to location, quantity or frequency, may be for any purpose and in any medium whatsoever, whether foreseen or unforeseen at this time, except where such use is in contravention of the law.

Permission is specifically granted for the Work to be edited, altered, distorted, used in whole or in part, in conjunction with other images, graphics, text and sound in any way whatsoever and without restrictions

Permission herein granted is absolute and final and shall not be subject to further inspection or approval by the Model at any stage in the use of the Work -- now or in the future.

Use of the Work may be in conjunction with the Model's own or fictitious names.

The Photographer shall own all rights in the Work which shall accrue to the benefit of his/her successors, legal representatives and assigns.

Notwithstanding the above and to be clear, the following uses are specifically noted and agreed to and specific exclusions for use listed here shall take precedence and restrict the use of the Work accordingly.

- THE PHOTOGRAPHER OWNS AND HOLD ALL RIGHTS TO IMAGES/PHOTOGRAPHS.

• **Whether a TFP or PAID Shoot, Photos will be used at the Photographer's discretion** such as on the Photographer's Website, in print, and on/in his Social Media Platforms/Forums such as Instagram, Twitter-X, Facebook, Model Mayhem, Model Society, AdultFolio, Purple Port, Kavyar, OnlyFans, Patreon, etc. **No discussions will be entertained as to content will be removed from any platform.**

• **Whether a TFP or PAID Shoot, Photos may NOT be altered AND/OR sold by the Model.**

• **A certain number of photos** will be given to the Model and *determined by the photographer*, and depending on length of shoot(s). Photos will be provided to the Model in a pixel grade suitable for use on the Internet – Social Media Platforms or Model's website.

• **The Model must properly credit the Photographer** when using/posting any photo. Whenever and wherever posted, written credit also must be given to Photographer and appear as on: **INSTAGRAM: PHOTO ©: @josephjbuckeekiiiphotography**

TWITTER-X: PHOTO: @2JB3PHOTOGRAPHY

The **Camera Icon/Emoji** OR **"Photo:"** may be used instead of © (copyright symbol) but must include proper photographer tag.

• **Photo credit MUST appear ABOVE and SEPARATE** from Hashtags and any CLEARLY posted separate and ABOVE brands.

• **If on model is on MODEL SOCIETY, ADUTLFOLIO, MODEL MAYHEM, PURPLE PORT, KAVYAR, etc.:** **Provide appropriate Tags** for those particular Platforms.

• **If the Model wishes to use photo(s)** for commercial or print media purposes, permission must be given by the Photographer.

• **Do not Hashtag** the Photographer or his photos.

• **If the Model is a minor and for safety reasons,** the Photographer never tags or posts the Model's name unless requested by and authorized by legal guardian. The Photographer can/will hashtag photos.

• **If Model is of legal age,** the name of the Model (or Model's professional name) will be used and tagged unless the Model requests otherwise. The Photographer can/will hashtag photos.

NDA (Non-Disclosure Agreement): EVERYTHING including all discussions/negotiations, agreements and actually working with the Photographer is to be kept confidential.

The Model warrants having read and understood this Model Release Agreement and warrants being of full legal age to enter into an agreement.

With full knowledge of the above, the Model hereby releases and shall hold harmless the Photographer and his/her successors, legal representatives, licensees and assigns from all claims, damages or injuries including but not limited to defamation or violation of right of privacy or publicity, resulting from or associated with the use of the Work.

The Model agrees that the provisions contained herein shall be binding upon the Model and his/her successors, legal representatives and assigns.

This Agreement shall be construed, interpreted and governed in accordance with the laws of the State of Florida and should any provision of this Agreement be judged by an appropriate court as invalid; it shall not affect any of the remaining provisions whatsoever.

The parties agree that any or all parts of this agreement may be submitted to the other party in person or in legible and recordable electronic form and upon acknowledgement of receipt by the receiving party shall become valid parts of the agreement.
