
THE : EMPIRE (1801-1849)

Equal rights for all regardless of religion. Hindus and Muslims occupied senior government positions. Dhian Singh, a Hindu Dogra, was Prime Minister of the kingdom.

JALLIANWALA BAGH WASSAFIE



On the 13th of April, 1919 a crowd of 20,000 people gathered at Jallianwala Bagh to celebrate Vaisakhi.

General Dyer arrived at the meeting with his soldiers and without warning, ordered his troops to fire at the crowd.

In 10 minutes 1650 rounds were fired.

The official figures state that 379 people were killed and 1200 were wounded, but in reality the casualties were much higher.



SAMANA SAHIB, 1921



In honour of Guru Nanak Dev Jee's birthplace there is a Gurdwara called Nankana Sahib.

It fell under the control of the corrupt Mahant Narain Dass, where he committed many sacrilegious acts.

Under the Gurdwara Reform movement, Sikhs decided to go and protest.


The Mahant hired 400 mercenaries to assert his control over the Gurdwara.

When the Sikhs arrived they were all brutally massacred.

Central Sikh League called a general meeting of all Sikhs in November 1920.

10,000 Sikhs attended and elected 175 members to form a managing committee for all Gurdwaras in India.


This committee was responsible for launching a movement to liberate all Gurdwaras from their corrupt custodians.


Although being dissolved by the Sarbat Khalsa in 1986, the organisation is still responsible for the maintenance of Gurdwaras in Punjab, Haryana and HP.

In 1921 the historical Gurdwara, Guru Ka Bagh, was under the control of Mahant Sundar Das.

The Sikhs led a campaign to free the Gurdwara.

On August 9 1922, the police arrested five Sikhs who had gone to gather firewood for the langhar (community kitchen).


To show their resilience Sikhs continued to gather wood. Yet again the police arrested them. This process continued.

Adopting a harsher stance, the police began mercilessly beating the Sikhs who came to be arrested.

The Sikhs gained possession of Guru ka Bagh after 5,605 arrested and 936 hospitalised.





Underwent a 116 day fast in jail to demand equal rights for British and Indian political prisoners.

On 23rd March 1931 he was hanged at the age of just 23.





PUNJABS I WATERS



The word 'Punjab' means the land of five rivers.

Partition in 1947 results in conflict over river waters between India and Pakistan.

In 1960 the waters of the Eastern Rivers (Ravi, Beas and Sutlej) allocated to India and the Western Rivers (Indus, Jhelum and Chenab) to Pakistan.

Punjab's economy largely dependent on agriculture, 75% of the population directly or indirectly dependent upon agriculture for their livelihoods.



SUPPRESSION OF A MINORITY

Punjab unjustly declared a bilingual state in 1956.

= Punjabi language downgraded.

Punjab drastically reduced in size, with large areas of land taken away by the Government (1966).

Punjab's river waters unfairly redistributed.

Sikh marriage ceremony comes under the 'Hindu Marriage Act (1955).' The Anand Karaj (Sikh marriage ceremony) is still not recognised as being distinct by the Government.



RIPARIAN RIGHTS

Riparian rights are internationally accepted and are based upon justice and equity. They have been approved by the United Nations.

International Environmental Law upholds Riparian Rights underlying principle. That is, when a river flows entirely within the territory of a state, its use is governed by that state.

This exact same principle is found in the Indian Constitution in Entry 17 of the List to the 7th Schedule.

"Water, that is to say, water supplies, irrigation and canals, drainage and embankments, water storage and water power subject to the provisions of Entry 56 of List I" Entry 17 Under List II of Seventh Schedule, **Indian Constitution.**

"Regulation and development of inter-State rivers and river valleys to the extent to which such regulation and development under the control of the Union is declared by Parliament by law to be expedient in the public interest." Entry 56 of List I of Seventh Schedule, Indian Constitution.

This means that matters involving water flowing between more than one riparian state is under the control of the Central Government, and so any disputes will be handled exclusively by them.



Reorganization

Under the Punjab
Reorganization Act (1966), the new states of Haryana and Union territory were created out of Punjab's land and eastern areas of Punjab were transferred to Himachal Pradesh.

Also included in the act was the transfer of Punjab river waters to other states.

Punjab had no surplus river water to spare, their total river flow was less than demand.



Total flow of all three rivers is 32.5maf while the demand was 52.5maf. ('maf-' Million Acre Feet =measure of water volume).

The 1976 distribution of Punjab river waters took place during an illegal State of Emergency declared by Indira Gandhi. Rajasthan was allocated 8.6maf, Haryana 3.5maf, Delhi 0.2maf and Punjab 3.5maf out of 15.8maf, which was falsely declared as surplus to Punjabs requirements.




Punjab's water redirected

Punjab has the exclusive right to Punjab river waters on the basis of riparian law.

The states of Haryana and Rajasthan are non-riparian and therefore have no legal or valid claim to Punjab river water.

The distribution of Punjab river waters by Indira Gandhi completely violates the Indian constitution.

Riparian law has been followed in India by all other states but Punjab has been made an exception.





TAL MAKE

CLEAR INJUSTICE: BUT DEMOCRACY FAILS THE PUNJABIS

The Punjab Government challenged the river water distribution in the Supreme court, deeming it to be illegal. But Indira Gandhi had the case withdrawn.

Water taken by the Indira Gandhi canal to Rajasthan has been used to irrigate the Thar Desert. This project has actually been condemned by several international authorities and has been branded as 'dubious and unjustifiable' by the World Bank.

The river water could have been utilised more efficiently in Punjab state. The water loss by evaporation in the diversion canals is extremely high in the hot dry desert climate of Rajasthan.

The issue of river waters has been mentioned in the Anandpur Sahib Resolution as Sikhs are the worst victims. Their lands are likely to become semi deserts and unfit for agriculture resulting in the ruin of their economy. Farmers have been forced to dig tube wells and extract unsustainable amounts of groundwater. This has led to a major looming environmental crisis of water scarcity.


SIKHS ROLE IN THE INDIAN ARMY

Sikhs fought in huge numbers for India in the Indo-Pakistan wars of 1947, 1965 and 1971 as well as the Sino-Indian war of 1962.

"....the main reason of our defeat was Sikhs fighting facing us. We were helpless to do anything in front of them. Sikhs are very brave and they have a great craving for martyrdom. They fight so fiercely that they are capable of defeating an army many times bigger than theirs." Crisis of Leadership, Maj. General M. Khan of Pakistan

Sikhs have won the maximum number of gallantry awards since independence.

Lieutenant Jagjit Singh Arora, known as the 'Liberator of Bangladesh' was searched and humiliated while passing through Haryana during the 1982 Asian games. Why were Sikhs, who were national heroes, suspected on going to sporting events, but not in the face of enemy bullets?



ANANDPUR RESOLUTION

- A selection of key points

To preserve and keep alive the concept of distinct and independent identity of the Panth and to create an environment in which national sentiments and aspirations of the Sikh Panth will find full expression, satisfaction and growth.

Eradication of Poverty, ill-health and Starvation.

Vacation of discrimination on the basis of caste, creed or illiteracy in keeping with basic principles of Sikhism.

Have all those Punjabi speaking areas, deliberately kept out of Punjab, to be merged back to constitute a single administrative unit where the interests of Sikhism are specifically protected.

In this new Punjab and in other States the centre's interference would be restricted to Defence, Foreign relations, Currency and General Communication.

The Sikhs and other religious minorities living out of Punjab should be adequately protected against any kind of discrimination.

Endeavour to have the Indian Constitution recast on real federal principles, with equal representation at the centre for all the States.



ANANDPUR RESOLUTION

continuation of points

Raises its firm voice against any discrimination against any Sikh (or even other) employees of the central or state Governments.

Endeavour to maintain the traditional position of the Sikhs in all wings of the defence departments and the Panth would pay particular attention to the needs of the Sikh army men.

An economic and social structure which provides for the uplift of the poor and depressed sections of society.

Seeks ban on the sale of liquor and other intoxicants and shall press for prohibition on the consumption of intoxicants and smoking on public places.

The arbitrary and unjust Award given by Mrs. Indira Gandhi during the Emergency on the distributions of Ravi-Beas waters should be revised on the universally accepted norms and principles, and justice be done to Punjab.
