The Market at Brock's Gap is a 501(c)(3) non-profit, state-certified market. Our farmers market consists of Alabama farmers, made-from-scratch food producers, and artisans. The Market at Brock's Gap is outdoors and open, rain or shine, on Saturdays only from 8 to 12 p.m. We set up in the parking lot of Brock's Gap Brewing Company in Hoover, Alabama, and plan to open our 2025 season on February 15 and remain open through November 15.

***We could extend our calendar if we have enough Alabama farmers who grow winter and late fall produce and can sustain the demand. That is TBD.**

We allow the following types of vendors at my market:

Alabama farmers

Food Producers

Artisan/Makers

Alabama farmers are required to have a growers permit.

Made-from-scratch food producers must have a current safe food handlers permit, be a licensed Cottage Food producer, or work out of a commercial kitchen. (Email proof of these with your application.)

No reselling or franchises allowed.

All vendors provide their own 10x10 straight-leg tent, tables, and chairs. (10 x 20 spaces are available also.)

If approved, a nonrefundable two-week deposit is required. This deposit will cover the last two markets of the season for which a vendor is approved. Weekly markets are drafted through Quickbooks one week before the market. Download the CC Authorization form from the website, complete it, and send it with the completed application. If a payment is declined, a \$35 late fee will be added; there are no exceptions. We do not refund any money for space requested in advance. If you requested the space and were approved, you bought it. We cannot replace vendors during the open season.
