Homeowners

Sub-standard electrical work puts you, your family and your property at risk. It can result in electrical fires and potentially fatal electric shocks that devastate lives. So choose wisely. Don't attempt the work yourself, ask family or friends 'that know how' or hire a tradesperson based on good references alone. Choose your local NAPIT member.

Some of the key things to consider for when hiring tradespeople are:

- Always use a tradesperson registered with a Competent Person Scheme (CPS), such as NAPIT
- Check the credentials of anyone you hire by asking to see their ID badge and checking with their scheme provider
- Get at least three quotes from different companies and agree what will be carried out and at what price in contract form

Landlords

Under the Landlords and Tenants Act 1985, the property you let should be safe when your tenants move in and be maintained in a safe condition throughout the tenancy. In the event that an accident occurs, it is important to be able to produce the correct certificates for notifiable electrical work and show that appropriate, regular safety checks have been carried out to meet this duty of care.

Tenants

As a tenant, you are responsible for the repair or replacement of anything you have broken or damaged. Your landlord must ensure all electrical systems (e.g. sockets, fittings and consumer units) within the property you rent are safe and that they comply with Building Regulations.

Who are NAPIT?


