1. SERVICE FEE

In the event of the mare proving negative, aborting or giving birth to a dead foal, or the foal dying within 24 hours after (vet certificate required) a replacement service will be provided. The mare owner is obliged to do everything possible to ensure a normal birth. In the event of the Stallion dying, a substitute stallion will be offered or frozen semen.

2. HANDLING FEE OR COLLECTION FEE

This is non-refundable and payable at each return to service.

Collection fee is payable prior to collection and despatch of chilled semen'

3. AGISTMENT

This is provided on the basis of paddocking or yarded and hay is included. Any extra requirements should be discussed with the stud and an additional cost agreed upon.

4. VET

If in the case of sickness or breeding difficulties it seems to be necessary to call the vet, the vet bills are quoted separately. Costs of pregnancy tests are also at the expense of the mare's owner.

5. THE MARE

Name and Signature of Mare Owner:

The mare should be delivered with her own head collar and hind shoes removed. Otherwise shoes are removed by the farrier at the expense of the mare owner.

- 6. The stud reserves the right to refuse any mare a service or agistment if, in the opinion of the Stud master, the handling of the mare appears to be too dangerous or impossible, or if the mare owner does not fulfil his/her part of the contract (i.e. payments, information), or if the mare proves to have an infectious disease. In such as case the mare's owner must collect her at once after being informed. Otherwise the stud has the right to have the mare transported to a veterinary surgery or to the owners address at the owner's expense. In this event the service fee will not be charged but all other stated costs remain payable.
- 7. All reasonable care will be taken of the clients horses whilst agisted at the stud but no responsibility will be accepted for death, injury, disease or reduced value of mare or foal whilst in our possession or in transit to or from the stud.
- 8. The owner of the mare and foal is reputed as the keeper of the animals and remains liable for damage by these horses.
- 9. The stallion owner requires detailed information about the mare and, if applicable, of the lessee of the mare, for her records upon delivery of the mare. The mare's owner has to report about any vices or other peculiarities of the mare or foal.
