- 1) HotShot GSP's guarantees that this dog is in good physical health on the day of pick-up. All applicable shots and de-worming have been done prior to this day.
- 2) The buyer agrees to take this dog to a licensed veterinarian of their choice within 48 hours of pick-up for a health check. HotShot GSP's must be informed immediately of the results of this examination. Should the dog be determined to be unfit for purchase due to illness, disease or congenital disorder, the cause of which is clearly attributable to the seller, the dog may, upon presentation of a written diagnosis and medical record from the veterinarian, be returned to the seller at the buyer's expense within 72 hours. Upon verification by HotShot GSP's veterinarian, seller will replace the puppy with another puppy of comparable quality when available, either from the same or an upcoming litter. No money will be refunded. If the puppy is not examined by a veterinarian within 48 hours after pick-up, all guarantees listed are not valid.
- 3) Buyer agrees to provide routine veterinary care for this dog including proper vaccinations, routine worm checks and heartworm treatment. In the event that buyer requests to return this dog for replacement, records of such care will be required to show the dog was properly cared for.
- 4) Under no circumstance will HotShot GSP's be responsible for veterinary fees or costs. Buyer is aware that owning a dog means regular trips to the vet and understands that he/she will be responsible for all costs.
- 5) Buyer understands that this contract will be void if buyer fails to provide routine veterinary care, if the dog is sold or transferred or if the dog is injured by accident. This guarantee does not cover any common canine ailments such as worms, vitamin deficiencies, viral or bacterial diseases or diseases brought on by parasites or lack of routine care.
- 6) HotShot GSP's will provide proper and verifiable registration papers/transfer of ownership papers as soon as they are processed and available.

- 7) Buyer will provide proper nutrition, care, exercise and training to ensure optimal growth and mental health of this puppy. If HotShot GSP's finds that any puppy/adult dog purchased from us is being abused or treated inhumanely in any way, we reserve the right to reclaim the puppy/dog at the owner's expense (without refund).
- 8) If the buyer is unable to keep a puppy or adult dog purchased from HotShot GSP's, buyer will return the puppy/dog to HotShot GSP's (no refund). Puppies/adult dogs may NOT be sold or transferred to another owner.
- 9) This contract is valid only for the original buyer and dog. It is not transferrable.
- 10) The buyer releases the seller, HotShot GSP's, from any and all liabilities and/or damages caused by this dog after pick-up. These damages include but are not limited to destruction of property and/or injury to any person.
- 11) As is customary, all puppies produced out of HotShot GSP's will take the kennel name. As the buyer, you agree to register this puppy in this manner. For example, if you name your puppy Mary Lou Who, the official registered name of your puppy should read "HotShot's Mary Lou Who." It is the buyer's responsibility to register their new puppy with the AKC.

This is a legally binding contract. Any and all legal action necessary to enforce this contract will take place in Stark County, Ohio.

We accept a \$200 non-refundable deposit to hold a puppy until the puppy is ready for placement. The remaining balance is due upon pick-up at 8 weeks old unless other written agreements have been made. Puppies are reserved on a first-come (first deposit received) basis.
