LEPC Exercises – Plan for 2022-2024 Exercise Cycle

August 30-31 Full-Scale Exercise

Exercise was conducted and was successful. The coordination between fire, law enforcement, ODNR parks, the pipeline operator, and adjoining counties was good and the drill provided good opportunities to practice incident assessment and incident command on a large event. Good coordination between public and private sectors. Recommended concurrence from SERC yesterday (10/12/22). The pipeline operator picked up some information about local contacts.

HazMat training

We are scheduled to have hazmat training according to the attached schedule. We are coordinating with the Ohio Fire Academy for Regional Delivery training which is funded through grants and does not cost the LEPC or fire department anything. If anyone else has hazmat training needs, please let Mike Sherron know.

Two sessions of HazMat Operations level training have been completed for DuPont's in-house emergency response team (\$665.84).

5. New Business

Tier II Reporting Facilities / Compliance Inspections / Pre-Incident Planning

77 total facilities have reported their chemical inventories

- 13 Fuel Bulk or Retail
- 4 Warehouse
- > 7 Manufacturing
- > 34 Oil & Gas
- ➤ 4 Utility / Transportation
- > 9 Propane
- 6 Agricultural

Spill Responses

August 11 – Partially sunk boat at Deer Creek State Park Marina August 23 – Commercial vehicle crash on US 23 SB at Sperry Drive (Sheetz).

Cost Recovery

➤ We worked through the cost recovery process as approved last October in the policy. An invoice for the Deer Creek Marina incident was certified to the prosecutor on August 11 and sent to the insurance company for payment from the July 11 boat sinking release. The invoice was not paid as of today, however the insurance company has indicated the payment has been approved and

issued. This invoice was for \$930.73 which covered three hours of Pic-A-Fay JFD's time with their engine and personnel along with the absorbent booms and EMA staff helping with the response.

- ➤ Pickaway Township FD requested reimbursement for oil dry used on a commercial vehicle crash on August 23. We sent the invoice to the insurance company and it was not paid as of today. This invoice was for \$286.22 to cover the costs of PTFD's engine, personnel, and the absorbents used during the response.
- In the Cost Recovery Policy approved at last October's meeting, there is a paragraph that stipulates an annual review of the policy. The policy was distributed with the agenda. Does anyone have any questions or suggestions for revision? Cost recovery has been established as a fund in the Auditor's system.

Annual LEPC Report

ESRI License
