COVID-19 Update

August 30-31 Full-Scale Exercise

We have been requested to partner with Enterprise Pipeline to conduct a full-scale exercise (a requirement once in a four-year cycle) on August 30-31 at Deer Creek State Park. They are already beginning the planning for this exercise and if we join in, we will need to send a request to SERC to include this pipeline as a "facility" under our LEPC jurisdiction. Enterprise is amenable to this inclusion.

HazMat training

We have received word from several fire departments in the county advising that they would like to have hazmat awareness and operations level training. Seeking funding from PUCO.

We are working with DuPont to build an operations level class for their employees to be presented in May in two sessions. The training can include local fire departments and Pickaway Township Fire has expressed an interest in participating in the training.

5. New Business

Introduction of Gary Cameron – New EMA Director

32 years with Columbus Police. Retired as a Commander. In retirement, needed something to occupy his time and became the Chief Dog Warden and served in that role for the past year. Appreciate the support of the County Commissioners in appointing me to this new role. This is week 4 and the steep learning curve is going to take time.

Tier II Reporting Facilities / Compliance Inspections / Pre-Incident Planning

We have received more than 70 facility reports for the 2020 reporting year. This includes several first-time filers. As a function of the LEPC, it is important to verify the information submitted and to develop pre-incident plans for the facilities. It is important to develop a facility inspection program and committee to include ad hoc representatives from the fire department having jurisdiction. The inspection committee can review the submitted information and develop the response plans to include (among other items) likely scenarios for off-property releases, work with EMS to ensure availability of treatment protocols for chemical exposure, and
