#### Lafayette USBC Open City Championship Tournament Rules

1. Entry is open to all sanctioned members of the Lafayette USBC Association and must have at least 3 games in a sanctioned Lafayette USBC league this current season. 2020/21

2. Highest average of 21 or more games from the previous winter season will be used. If no previous winter season average, then the highest summer (non-sport) league average of 21 games or more will be used. If no previous winter or summer league average, the current season average of 21 games or more may be used. All other bowlers will be assigned an entering average of 200. Sport averages will be converted using the USBC chart. It will be the entrant's responsibility to verify the accuracy of their average. Failure to use correct average will result in scores being disqualified. Corrections to averages and scores must be made within 48 hours of the completion of the series. USBC rules 319d (prize winnings) and 319e (entering average adjustment) will not apply.

3. USBC rule 319a-2 (10 pin rule) will apply.

4. Multiple participation will be allowed per USBC rule 315b. (<u>3</u> team entries, <u>2</u> doubles entries, and <u>1</u> singles entry per person) In team event at least two players must be different, doubles event at least 1 player must be different, the bowler's first appearance is for All Events, but can cash more than once in Doubles and Team events.

5. Protests will follow USBC rule #329

6. The all-events division is an optional event. Entrants must have paid the optional all-events fee to cash or win. The entrant's first appearance in each event counts towards their all-events total. Team event will be January 10,17,24,31...

7. The tournament prize ratio is 1 in 5 with 100% of the prize fund returned.

8. Dress Code: NO vulgar or obscene clothing will be allowed. Clean decent clothes please.

9. Winners will get their choice of Polo Shirt, Windshirt.

10. Any entries received within 48 hours of the bowlers squad time, will be subject to a \$5.00 per person/per event walk-in fee.



### Lafayette USBC 2020-21 City Tournaments Pandemic Rules

Due to the very fluid Covid-19 situation we all are facing today, the Lafayette USBC would like to explain how we plan to conduct the City Tournaments. There will be many meetings with the center, plus local, state officials in the coming days and weeks, so nothing is set in stone. Please understand plans may change often, and with very short notice.

- 1. The Lafayette USBC Open & Women's City Championship Tournaments plan to start on January 9th at Mike Aulby's Arrowhead Bowl and run 4 consecutive weekends. USBC rules state that any sanctioned tournament that has to be cancelled due to extreme circumstances (covid-19 pandemic, bowling center restrictions or weather) during the course of the competition will be considered officially over. Even if we are forced to cancel the tournament after the 1st, 2nd, or 3rd weekend, the tournament is considered complete. Final standings will be posted accordingly. With many people getting together for the holiday's, we could see another large outbreak of cases in about 10-14 days, so this would hit during the tournament. It is very possible that we may not get to complete the 4 weekends of the tournament, or at least be restricted on numbers of bowlers allowed in the center at one time. We just don't know what may happen.
- 2. Anyone who prepays, but does not get to bowl any events because of illness, is quarantined or the tournament was cancelled, will get a full refund. If a bowler has pre-paid for any or all of the 3 events, but does not get to participate in some of the 3 events due to illness, under quarantine or cancellation, money will be refunded for ONLY for the events not bowled.
- 3. The Tournament host, Mike Aulby's Arrowhead Bowl <u>strictly</u> enforces the mask mandate. The Lafayette USBC tournament officials FULLY expect ALL bowlers to honor this. Masks are to be worn at all times except while physically eating, drinking or on the approach bowling. Failure to abide by this rule could result in disqualification without a refund. If you are not willing to wear your mask, we would appreciate and understand if you don't bowl this year. We want to keep everyone who wants to bowl to be as safe as possible.
- 4. Due to time constraints, the Lafayette USBC City Championship Tournaments cannot be postponed until later in the spring <u>UNLESS</u> the Indiana State USBC postpones the start date of the Youth State Tournament by several weeks. MAAB is scheduled to host the 2021 Indiana State Youth Championship Tournament from February 27th - April 25th, so the local board will be busy helping every weekend run that tournament.

<u>Schedule of events:</u> City Tournaments: Every weekend of January, the 9th - 31st. February 6/7 is Super Bowl Weekend. February 13/14 Lafayette USBC Masters/Queens Tournament. February 20th-Hall of Fame/Recognition Banquet. February 27th starts State Tournament.

- 5. Plans are to put 1 team per pair, 2 sets of doubles/singles per pair.
- 6. Team Captains (including singles & doubles) are asked to inform all their bowlers of these above rules to ensure there are no misinterpretations of these Pandemic Rules.
