Mr. Patrick made a motion to approve the minutes from May 8, 2023; it was seconded by Mr. Lange and passed.

Fire Department

Captain Paul Jalbert reported 118 Fire/EMS this year; up 25 calls year-to-date.

Chief Porter is requesting to purchase an HP Deskjet printer/scanner and ink.

Fiscal Officer

Ms. Forgacs reports there will be a special election on August 8 with issues for Charlestown. #6-2023 Mr. Patrick made a motion to accept the amounts and rates as determined by the budget commission and authorizing the necessary tax levies and certifying them to the county auditor. It was seconded by Mr. Lange. Roll was called; all votes yes. Motion passed.

#7-2023 Mr. Patrick made a motion to accept a resolution declaring the necessity of a renewal of an existing (1.5 mill) levy for a tax exceeding the ten-mill limitation for the purpose of current township expenses. It was seconded by Mr. Lange. Roll was called; all votes yes. Motion passed.

#8-2023 Mr. Patrick made a motion to accept a resolution declaring the necessity of a renewal of an existing (0.7 mill) levy for a tax exceeding the ten-mill limitation for the purpose of current township expenses. It was seconded by Mr. Lange. Roll was called; all votes yes. Motion passed.

Submitted over \$7000 to be reimbursed for past NOPEC grants.

Submitted annual BWC injury report.

Still working at fire phone with AT&T.

Need to have the budget meeting soon. Everyone available for June 26. Will place ad in paper.

Still working on record retention policy.

Trustees

Mr. Eskridge discussed plans for the Memorial Day parade as made by the activity committee. Firefighters to help direct parking in the park so parade participants can stage in the garage parking lot; VFW and military vehicles confirmed.

Trash dumpsters were well-used last weekend. Noted someone dropped off 7 tires next to the dumpsters. Mr. Lange to research when the next tire drop-off event with the health department is scheduled.

Attended the County Township Association meeting with Mr. Lange; large solar farms were the topic of discussion; shared solar panel information received from the Prosecutor's office. The County Commissioners did receive the letter from trustees stating the Charlestown Township trustees do not support large solar farms or wind farms in the township. County commissioners will continue to discuss; they have the authority to authorize large solar / wind farms anywhere in the county but want to honor to trustees' decisions if not supporting this.

Mr. Lange, Mr. Grund and several firefighters disposed of the old, broken metal tables. Looking into replacing with plastic tables.

Mr. Lange made a motion to spend up to \$500 to replace the tables; it was seconded by Mr.

Patrick and passed. Mr. Patrick to research for the best price and quality.

#9-2023 Mr. Patrick made a motion to use ARPA funds to purchase tables for township events and to pay for Fire MARCS radio fees. It was seconded by Mr. Lange. Roll was called; all votes yes. Motion passed.

Mr. Larry Jenkins was sworn in as the county engineer at the township association meeting. Spoke with Mr. Brett Bencze regarding the process to acquire additional property for the cemetery. Mr. Bencze states cemetery property cannot be within 100 yards of a residence; Mr. Lange to research.

The Newton Falls Road bridge is scheduled to open May 23.

The Health Department Advisory Board to meet with candidates interested in filling the vacant board position.

Mr. Patrick asked the trustees to review the draft policies they have now for discussion at upcoming meetings.

Mr. Patrick moved the adoption of the following resolution:

WHEREAS, Charlestown Township currently has in effect a 1.5 mill levy for the benefit of Charlestown Township for the current expenses of the township as more fully set forth in R.C. 5705.19(A), which was before the electorate in 2018 as a renewal levy and a renewal of that levy requires a of the people pursuant to R.C. 5705.19(A), R.C. 5705.191, and R.C. 5705.25.

WHEREAS, the amount of taxes which may be raised within the ten mill limitation will be insufficient to provide an adequate amount for the necessary requirements of the Township of Charlestown, Portage County, Ohio;

WHEREAS, a resolution declaring the necessity of levying a tax under R.C.5705.19(A) outside the ten-mill limitation as per 5705.03(A) must be passed and certified to the county auditor of Portage County in order to permit the Board of Trustees to consider the levy of such a tax and must request the county auditor certify to the Board of Trustees the total current tax valuation of the Township of Charlestown, and the dollar amount of revenue rounded to the nearest dollar that would be generated by a 1.5 mill renewal levy for each one hundred thousand dollars of the county auditor's appraised value; and an estimate of the levy's annual collections, rounded to the nearest one thousand dollars.

RESOLVED, by the Board of Trustees, two-thirds of all members elected thereto concurring, that it is necessary to levy 1.5 mills, to constitute a tax in excess of the ten-mill limitation levied upon the entire territory of the Township of Charlestown and for the benefit of the Township of Charlestown under R.C. 5705.19(A) for the following purpose:

For current expenses of the subdivision, except that the total levy for current expenses of a detention facility district or district organized under section 2151.65 of the Revised Code shall not exceed two mills and that the total levy for current expenses of a combined district organized under sections 2151.65 and 2152.41 of the Revised Code shall not exceed four mills;

As provided by Ohio Revised Code Section 5705.19(A) at a rate not to exceed 1.5 mills for each one dollar of taxable value, for the tax years 2023, 2024, 2025, 2026 and 2027.

RESOLVED, that the renewal levy be placed upon the tax list commencing in 2023 and first due in calendar year 2024 in compliance with Ohio Revised Code section 5705.34, if a majority of the electors voting thereon vote in favor thereof and,

RESOLVED, that the question of such renewal tax levy shall be submitted to the electors of the Township of Charlestown in its entirety, at the election to be held therein on November 7,

2023 and,

RESOLVED, that the Fiscal Officer is hereby directed to certify a copy of the resolution to the county auditor and that the county auditor certify to this board of trustees the following:

(i) the total current tax valuation of the Township of Charlestown

(ii) the dollar amount of revenue that would be generated by a renewal levy of 1.5 mills if approved by the electors and

the renewal levy's rate expressed in dollars, rounded to the nearest dollar, that would be generated by 1.5 mills for each \$1 dollar of taxable value, for each one hundred thousand dollars of the county auditor's appraised value;

(iv) an estimate of the renewal levy's annual collections, rounded to the nearest one

thousand dollars.
