The regular meeting of the Charlestown Township Board of Trustees was called to order at 5:30 pm by Mr. Adam Eskridge on May 23, 2022 with the Pledge of Allegiance.

Trustees – Chairman Adam Eskridge, Bruce Lange – present, Vice-Chair Tim Patrick - absent; Fiscal Officer - Susan Forgacs present.

Mr. Eskridge moved to approve the minutes from the regular meeting on May 9, 2022. Mr. Lange seconded the motion. All votes were yes, motion carried.

#### **GUESTS**

Mr. Greg Postlethwait present to discuss the racetrack. States there was a practice scheduled last weekend that was postponed to the Memorial Day weekend. Reports there are new tenants in the rental.

The track owner, Mr. Jeff Allen, has not picked up any of the certified mail sent by the township or the prosecutor. Mr. Lange states the prosecutor may have to have the Portage County Sheriff's Office serve him the documents. The Portage County Health Department is also having troubles contacting Mr. Allen; they want to do a dye test on the rental property septic system. Mr. Postlethwait thanked the trustees for working on this.

Mr. Joe Tenney will offer to buy the landlocked property behind his house this weekend. Asked if the township does property valuations; answer is no. Asked if the right-of-way agreement stays with the property. No one has been able to find paperwork; probably was a hand-shake agreement. Recommend discussing with Mr. Shaylor, the property owner of the right-of-way.

#### Zoning

Mr. Rick Grund received phone call from Esworthy Road resident asking about fencing regulations. Signed off on the replat map survey approval for Mr. Curtis Wiley's property on Garrett Road.

### Fire Department

Assistant Fire Chief, Don Hanna, asked about upgrading the water softener unit that supplies the townhall and the fire station. Mr. Lange will have the softener tested and ask for recommendations.

Fire Chief, Randy Porter, reports 98 Fire/EMS calls for the year; up 5 calls from last year.

All of the fire departments from the Southeast School district have been invited to participate in the Memorial Day parade.

The computer monitors have arrived so the upgrades can begin.

Looking into dispatch options with the Portage County Sheriff's Office. Ravenna City Fire dispatch has issues with how to page out the emergency calls; the fix is to buy new equipment which isn't planned to happen until the new station is built in at least 2 years. Ravenna City wants to send page via the VHF radios and then dispatch on the MARCs radios but we are trading in the VHF radios to keep the cost down on the new radios. PCSO is already the public service answering point (PSAP) for Charlestown; which means the calls are initially answered by PCSO the forwarded to Ravenna.

Mr. Eskridge received call from Mr. Ed Sameck, Paris Trustee, about our cemetery pricing; he reported an increase in Newton Falls residents being buried at the Paris Cemetery. They have a local resident who volunteers to do yard work at the cemetery.
