



### Fire Department

Fire Chief Randy Porter reports 246 Fire/EMS calls year-to-date; down 3 calls compared to last year. Ready to help Santa deliver gifts on Saturday.

Will be sending a request to the State Fire Marshall's Office to reimburse \$7000 for training.

Mr. Patrick made a motion to spend up to \$7000 for uniforms as requested by Chief Porter; it was seconded by Mr. Eskridge and passed.

### Fiscal Officer

Ms. Forgacs received the annual request for Fire Dependency Board members list; will be completed at the Annual Reorganizational meeting and submitted.

The Annual Reorganizational Meeting is January 12, 2026 at 5:30 pm prior to the regular business meeting; will place ad in Record-Courier.



Received letter from NOPEC confirming the township's departure from the aggregate.


Mr. Eskridge also thanked Mr. Patrick for his service and said it has been great working with him.
