The regular meeting of the Charlestown Township Board of Trustees was called to order at 5:30 pm by Mr. Bruce Lange on Monday, June 14, 2021 with the Pledge of Allegiance.

Trustees – Chairman Bruce Lange, Vice-Chair Adam Eskridge, Tim Patrick – present; Fiscal Officer - Susan Forgacs present.

Mr. Lange moved to approve the minutes from the regular meeting on May 24, 2021. Mr. Eskridge seconded the motion. All votes were yes, motion carried.

Mr. Lange moved to approve the financial reports; it was seconded by Mr. Eskridge. All votes were yes; motion carried.

REPORTS

Zoning

Mr. Rick Grund reported a zoning permit request for a 9' X 12' building on Beaver Road; the property is only 0.25 acres so cannot get an agricultural permit; will get more information / drawings to Mr. Grund.

Fire Department

Fire Chief Randy Porter reports 111 Fire/EMS calls for the year; up 18 calls from last year. Will be doing air pack maintenance in June.

The personnel attending fire school are halfway done.

GUESTS

Greg Postlewaith, Peggy Postlewaith, Chris Webb, Janeen Webb, Ruby Pahls and Pat Robinson present to discuss Ohio International Raceway concerns.

Mr. Brett Bencze from the Portage County Prosecutor's office present to answer potential zoning questions.

Discussion lasting 1 hour and 25 minutes was held.

Summary of Mr. Bencze's comments:

- He represents the township's interests
- His comments should not be construed as legal advice; Recommends residents obtain private legal counsel who has more capabilities to advise and pursue
- The lawsuit from the 1970's against the racetrack was brought by township residents and not the trustees; the township trustees do not have the authority in enforce the guidelines that were established

- The racetrack was in place prior to zoning; it is considered a non-conforming use property
- Current zoning regulations have language that suggests noise and dust can be an issue, but stated his experience shows those cases are difficult to win, especially since it is only two days per month
- The best option is to show the property was dormant for more than 2 years; it would then revert to residential R-1 status.

Summary of the residents' concerns:

- Increased dust and noise
- Widening of entrance drive
- Lack of available schedule
- People camping on property
- Trash blowing into other properties; no trash cans available
- No first responders at track; this typically is a requirement for insurance coverage or sanctioned races, which are not being held; just practicing
- Concern over possible increase in issues if not stopped now
- Postlewaiths report feeling threatened and fear reprisals; have their property under surveillance; Peggy Postlewaith states she filed a police report for one of the track workers allegedly trying to run her off the road.
- Janeen Webb stated "the track owner does not seem to care about the township".
- Asked if Rick Grund could inspect the track on race day as the zoning inspector; Mr. Bencze stated the zoning inspector can go to the track but the track owners can tell him to leave.

Trustee, Mr. Bruce Lange, reported the Portage County Combined General Health District was asked to assess the property. The written report is pending but the verbal report stated the material placed in the drive way was ok to use; reinforced there is to be no camping on site; food vendors must be licensed in Portage County; the rental house located on the track property does not have the grey water from the laundry plumbed into the septic tank as it should be. Mr. Lange gave the example of the Route 5 Sand & Gravel Pit that was dormant for more than 2 years and now has reverted to R-1 status.

Next Steps:

- Pat Robinson asked about adding zoning amendments; Mr. Lange reported the property is "grand-fathered" since in business prior to zoning.
- Chris Webb asked if the zoning board can look at the language of "practice" versus "racing" to limit future concerns.
- Residents to contact a trustee if violations noted; Mr. Grund will be asked to investigate
- Mr. Patrick asked about doing a noise assessment
- Residents to start documenting issues and looking for concrete evidence that operations has ceased for more than 2 years.
- The trustees asked Mr. Bencze to draft a letter requesting a schedule

#6-21 Mr. Patrick moved to accept an emergency resolution to hire Butcher & Sons to finish the clean-up at Crest Rubber property for \$12,500; it was seconded by Mr. Lange; roll was called; all votes were yes; motion carried.

Mr. Patrick stated the original estimates from the salvage company was \$50,000 - \$60,000 to remove building and clean-up; total costs will be less than estimate.

Mr. Patrick made a motion to have DBI spray the guard rails for \$1005.34; seconded by Mr. Lange and passed.

#7-21 Mr. Lange made a motion to have Adam Eskridge fill Joe Boetler's vacant space on the Ravenna Arsenal Board; it was seconded by Mr. Eskridge; roll was called; all votes were yes; motion carried.

Mr. Lange reported the fire station has been painted; will do town hall in July Linda DeHaven requests we let her know when the town hall is being used. Need to replace Fivar (playground surface)
