Zoning

Fire Department

Assistant Fire Chief Paul Jalbert reports 84 Fire/EMS calls this year; down 18 calls from last year. Estimates for repairs to 1315 were reviewed; need to clarify cost for a couple items – compressor for the air conditioner and exhaust manifold.

Replied to a request from real estate agent regarding any possible liens on the property just east of Crest Rubber on Newton Falls.

Mr. Patrick made a motion to accept the lowest bid received from Evans Land Improvement for \$5100; it was seconded by Mr. Lange and passed.

Mr. Patrick made a motion to accept to bid from Perrin Asphalt to make repairs on McCormick, Garrett, Esworthy, Vair, and Hanna roads for \$5975; it was seconded by Mr. Lange and passed. Reports Mr. Chuck Keiper is scheduled to attend to commissioner's meeting this Thursday to discuss NOPEC. Mr. Patrick consulted with Mr. Chris Meduri regarding the steps needed for the township to no longer be a member of NOPEC; was advised to pass a resolution. #4-2024. Mr. Patrick made a motion to adopt a resolution to remove Charlestown Township
