Zoning

Mr. Bruce Lange reported for Mr. Rick Grund – letters will be sent to the property owner at 5975 Knapp road regarding the state of the property. Discussion was held regarding concerns with modular homes versus mobile homes versus real property; still researching. Will ask Mr. Grund about status of Newton Falls property status behind Joe Tenney's residence.

Assistant Fire Chief Don Hanna reports 195 Fire/EMS calls for the year; up 30 calls from last year.

Mr. Eskridge reported attending the Ravenna Arsenal Board virtual meeting; reported EPA updates and monitoring; will meet again in April.

Spoke with an EPA consultant regarding possible Crest Rubber property clean-up grants; will schedule a meeting.

Township website has had 44 visitors.

Mr. Lange reported the pickup truck being auctioned needs a battery. Hayes Auctions will replace the battery and subtract the cost from the proceeds. Will deliver the title to the auction. Received several phone calls from residents regarding work being done on the septic system for the racetrack apartments on a Sunday by the track employees. The Portage County Health Department was notified to investigate. The trustees will be sending another letter to Mr. Allen regarding the motorcycle track operations and zoning concerns.

The dead trees at the park have been removed and several stumps have been ground.
