The 0.7 mill General Fund levy originally passed in 1983; effective millage due to the reduction factor is 0.253432.

The 1.50 mill General Fund levy originally passed 1988; effective millage is 0.550974,

The 1.50 mill Fire Levy originally passed 1989; effective millage is 0.571158.

The 2.50 mill Fire Levy originally passed 2000; effective millage is 1.584923.

The 1.50 mill Fire Levy needs to be placed on the ballot this November. Chief Porter has been gathering information from the Portage County Auditor regarding revenue expected from this levy and other options available.
