Below is the project construction status update. As of the writing of this memo the Project stands at 85% complete of the Contract's scope of work. Major work items are anticipated to wrap up in early November 2020 but there may be some small "punch list items to complete, mainly in the form of restoration work.

#### Work in Progress and Anticipated Work (October 2020)

### CIPP Lining

- E Belvedere Ave North side of the street Between Clearspring Road and Orkney Road
- o 5913 5919 York Rd

Work crews will access existing sewer lines via manholes to insert new lining sleeves into the pipes which will be "cured in place" effectively creating a new structural pipe. Residents may be asked to reduce their wastewater producing activities during this process, ie. laundry, dishwashing, excessive toilet flushing, etc., with full service restored at the end of work each day.

## • Point Repair Work (Open Cut)

- York Road at Evesham Avenue
- o 1327 -1349 Stonewood Road
- o 4410 Kenilworth Ave
- o 922 43rd Ave
- o 1307 Kitmore Rd

For this work residents will be requested to limit their usage of the waste producing facilities, (ie. Toilet flushing, clothes washing, dish washers, etc.), during the active work hours from 8 AM to 3 PM. There will also be noise from excavation equipment and cutting tools and in some instances water usage may be limited.

#### Manhole Location and Elevation Adjustments (Open Cut)

Various Locations

Existing manholes are identified as not meeting the existing grade and will be adjusted accordingly to created adequate maintenance access and safe traffic conditions. For this work there will not be any disturbance of service to residents. There will be some noise and temporary traffic modifications to facilitate this work.
