and within the fenced areas of the facility unless instructed otherwise by a CampWannaQ instructor(s)/owner(s).

It is expressly understood that the handler(s) alone is responsible for the behavior of their dog(s) and/or children at all times. Any handler whose dog(s) creates unnecessary disturbances or repeatedly engages in unsafe, disruptive, or AGGRESSIVE behavior, may, at the discretion of a CampWannaQ instructor(s)/owner(s), be asked to leave the facility and/or terminate class instruction.

**AGREEMENT**

I hereby assume the sole responsibility for, and agree to, indemnity and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves) or on account of damage to property, arising out of or in consequence of my (our) participation at this facility.

I hereby agree any matter arising from claim, from loss, or from injury shall be subject to the laws in the State of California and that binding arbitration shall resolve any such matters.
