

MURAL COMMISSION AGREEMENT



1. SCOPE OF WORK

The Artist will design and execute a custom mural based on the agreed concept, dimensions, and surface conditions.

Final design must be approved before painting begins. Any deviation from the approved design may result in additional costs or cancellation of the project.

2. PRICING STRUCTURE

Every mural is different, so we don't apply one flat price to every square foot. Instead, we look at the complexity of the artwork and divide the mural into different levels of detail. We calculate the amount of each type of artwork in your design and combine those areas to create your final price. The result is a custom quote based on your wall, your design, and the level of detail you want.

Additional Costs May Apply For:

- Textured or uneven surfaces
- Exterior/weather-exposed surfaces
- Waterfront or difficult access locations
- Surface prep (cleaning, sanding, priming, sealing)
- Travel beyond standard service area
- Panel construction and installation
- Panel Work (Preferred)
- Panel murals are recommended for durability and control
- Installation labor is billed separately

The Artist does not accept projects requiring:

**lifts, cherry pickers, scaffolding, or heavy equipment
unsafe or inaccessible working conditions**

All murals must be safely accessible by 6-12ft ladder.

If site conditions require restricted equipment, the project must be re-scoped or declined.

4. ESTIMATES & VALIDITY

All quotes are estimates only and subject to change based on:

- on-site inspection
- final measurements
- surface conditions
- design revisions

5. PAYMENT TERMS

Standard Structure:

50% deposit (required to begin mural project)

50% due upon completion

Installment plans may be arranged at the Artist's discretion.

IMPORTANT: No work begins without payment agreement

Final payment is required upon completion. (Within 72 hours)

6. DESIGN & REVISIONS

Includes up to 2 design revisions

Additional revisions will incur extra charges

7. TIMELINE

Timeline depends on:

- **project size & complexity**
- **weather conditions**
- **scheduling**

Delays caused by weather or site issues are not the responsibility of the Artist.

8. ASSISTANT & PROJECT SUPPORT

We (the artists) may bring an assistant and/or panel installer to assist with:

- **logistics**
- **setup**
- **installation**
- **other safety needs**

9. CLIENT RESPONSIBILITIES

Client agrees to:

- **provide safe and accessible workspace**
- **ensure site is ready for painting**
- **allow consistent access during scheduled work**

10. CANCELLATION POLICY

Deposit is non-refundable once work has begun

Client is responsible for work completed up to cancellation point

11. ARTIST RIGHTS

The Artist retains the right to:
photograph and document the work
use the mural for portfolio, marketing, and promotional purposes

12. LIABILITY

The Artist is not responsible for:

- structural issues of the surface
- pre-existing damage
- environmental wear over time

13. MURAL DESIGN PRICING

Any mural design requires a 50% deposit before beginning.
Remaining design balance due upon completion of design.
Deposit is Non-Refundable
