1. Terms:

Once your booking is confirmed, you are accepting the terms set out below.

2. Amendment of terms:

These terms are subject to change at any time and are effective upon posting on the website. It is advised you check back regularly in the case of any amendments.

3. Prices

- **3.1)** Our prices are guidelines, if upon arrival it is deemed that there are excessive levels of pet hair, vomit, bodily matter or anything that requires extra time to rectify that has not previously been disclosed CB Valeting & Detailing reserve the right to apply a surcharge.
- **3.2)** Travel is included for the first 30 minutes, excess of 30mins will be charged at £20p/h both ways.

4. Booking and Cancellation:

All bookings are subject to a 20% deposit, if the deposit is not received your booking is not confirmed. Deposits are non-refundable but are transferable if 48 hours' notice is given. This also gives you, the customer, the complete confidence and piece of mind that your booking is confirmed and your appointment date is blocked off in the diary.

5. Timings:

Estimated times of arrival and service completion may be provided, these are only estimates. We do not guarantee that bookings will be started or completed within the estimated times.

6. Cancellation due to Weather:

CB Valeting & Detailing carry out car care services all year round, on some occasions, the weather prevents us from pursuing our duties. If no sheltered work area is available, bad weather may regrettably force us to cancel. We will contact you by phone or email to confirm the cancellation and to re-schedule a more suitable appointment at no cost.

7. Service Delivery:

7.1) It is the customer's responsibility to ensure your vehicle is in a reasonable condition by removing excess items, personal belongings and child car seats (if

applicable) from the interior and boot area. Items that may resemble rubbish could be considered disposable and therefore removed and disposed of. CB Valeting & Detailing will not be held responsible in such a situation.
