



CREEKSIDE CABINS AND RV PARK GUIDELINES

Quiet Time

- Monday Through Friday 10:00pm to 6:00am
- Saturday 11:00pm to 10:00am
- Sunday 10:00pm to 6:00am

General Guidelines

- Speed Limit is 10 MPH in park.
- No parking in empty spots.
- No driving or parking on grass.
- Guest of tenants must parallel park to the road.
- All septic hoses must be airtight with threads.
- No leaks in your RV water. (Water, Septic, Propane, etc.)

Housekeeping

- Keep your area tidy and clutter free.
- Do not leave trash bags outside of RV. (There is a dumpster on the premises.)
- Do not throw cigarette butts on the ground.

Tenants

- The park manager must have a working phone number in which to reach you in case of an emergency or nonpayment.
- Rent must be paid on time or late fees will apply.
- You are responsible for enforcing park guidelines on your guest.
- Refrain from walking through other tenants RV camp area.

Charcoal Grilling and Campfires

- No campfires or charcoal grilling during a burn ban. (Check with the office if you are unsure).
- Fire pits must be:
 - Metal with screen lid
 - Above ground
 - No holes in the pit that drop live ashes on the ground.
 - No digging fire pits in the ground.
- When charcoal grilling does not dispose of ashes on the ground. Put ashes in the dumpster after making sure the ashes are completely out.



Dogs

- Please clean up after your dog. (Do not leave waste on the ground.)
- Do not tie up dogs and leave them unattended.
- No excessive barking.
- No aggressive dogs. Aggressive dogs will be removed from the premises.

Decks

- Decks can be constructed after approval from the office.
- Decks must be constructed professionally.
 - Must be 100% constructed using treated lumber.
 - Screws
 - Deck base blocks.
 - Size must be 8'x12' minimum.

Satellite

- No satellite poles are to be put in the ground without approval from park manager.
- If satellite dishes are left on the ground, they must be moved on mowing days.

I, _____, have read the above and promise to abide by these park guidelines. I also understand that in the event of a disturbance which I am involved in, I could be asked to leave the premises immediately with no refund. Furthermore, I give Creekside Cabins and RV Park the authorization to move my camper out of its intended site by any means whether by truck or tow company for reasons of non-payment couple with non-communication. I understand the RV will be held in storage until rent has been caught up and the cost of moving the RV plus the cost of storage has been paid in full.
