## Deposit/Reservations/Payments

# All orders require a NON-REFUNDABLE deposit of half the rental, which is due at time of booking.

After a reservation is confirmed, customer will receive an email which includes Equipment Rental Agreement Form, Waiver Form, and Safety Procedures/Rules Form.

All documents are to be signed and returned before day of event. Documents can be completed and returned via email PROJECTTHENIGHT7@gmail.com. A photo of the signed documents along with the renters drivers licenses can be texted to 404.857.6342.

Remaining balance on all orders are due 7 days prior to event. • Visa, Master Card, Discover and Cash, are accepted forms of payment.

#### **Cancellations:**

Should you have to cancel for any reason you will have 48 HOURS PRIOR TO EVENT DATE to cancel to receive a RAIN CHECK. REMAINING BALANCE PAID is any fees paid after the deposit fee. Delivery/Set up/Take down

Rentals are set up 1hour prior to event (not included in rental time). 1 hour for take down/clean up (not included in rental time). All rentals are 4 hours, prices are not adjusted for shorter times. All rentals must end at 8pm or sooner.

Power source needed for inflatables. Outdoor Events Equipment should be placed on flat ground, preferably on low grass. Equipment will not be set up on or in wet grass, muddy or dirty areas. Shady areas are recommended during summer (hot days) to ensure that the equipment does not become too hot for participants. Alternatives areas or space should be made available in case of unfavorable weather. Inclement Weather Project The Night, LLC will not set up in rainy weather that will jeopardize the safety of participants and to ensure the protection of the equipment. If equipment is already set up, a "Rain Check" will be issued due to the weather conditions. No Refunds will be issued.

### **Cleaning Procedures/Fees**

All equipment is cleaned, sanitized, and disinfected before and after each event. Project The Night, LLC strives to provide a clean environment for participants. It is our priority to ensure that all equipment is free of germs. Customers will be responsible for a **\$150 cleaning fee** if equipment is very dirty or show signs that the rules stated in the "Safety Procedures/Rules" form was not adhered to.

### **Damaged Equipment**

If any equipment is damaged in the customer's possession beyond a point where it can be fixed, customer will be responsible for replacing the equipment.
