They are considered not received if an email non-delivery notice is received by the sender. If a non-delivery notice, returned to sender as undeliverable, is not received at dvatmbhoa@gmail.com then the email sent from this address is assumed received IAW Washington [RCW 24.03A.015 Notice](#).
5. All email addressed to the Architectural Review Committee (ARC), the Board of Directors (Board), or any other Board approved committee, must be addressed to dvatmbhoa@gmail.com. Email directed to personal email addresses is not official HOA communications and will not be accepted as such.

If you don't consent to receive such notices and reports via email then they will be delivered using USPS First Class mail to the address as it appears on the Cowlitz County Tax Assessor's record, or as designated by you as your address of record. Such notices shall be deemed to be delivered when deposited in the US Mail using your address of record. Owners who don't provide their consent to use email for notifications will be charged \$1.00 for postage and handling for each notice sent via USPS.
