1. Welcome: Dale welcomed members and tabled the reading of August's minutes.

3. Dale then asked all of our Veterans to stand and be recognized and welcomed them.
4. Dale announced that Joan Edleson, Marci Potter and Larry McDaniel were finishing their terms as Board members/and thanked them for their service.
