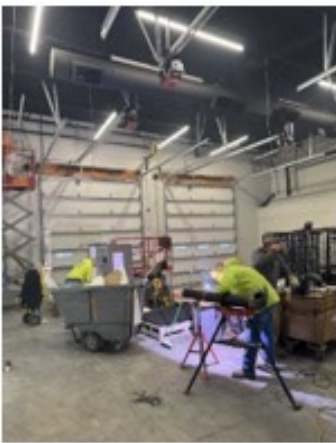
We will have a guest speaker from the K-9 Unit who will talk to us about how their dogs help fight crime throughout our area.
