- 4. After approval is given, the project must be completed within a 90-day period.
- 5. I have read this application, the Association's CC&R's, and the Architectural Standards and Procedures, and I understand and agree to the terms and conditions of the Architectural Control Committee's review of my application, plans and specifications, as stated therein.
- 6. INSTALLATION TO BE AT NO COST WHATSOEVER TO THE ASSOCIATION. ANY FURTHER MAINTENANCE SHALL BE THE RESPONSIBILITY OF THE OWNER, HEIRS OR ASSIGNS.
- 7. AS OF 1/1/06 PATIO FENCE EXTENSIONS ARE NO LONGER ALLOWED.
